- 2. GEDAC Composition 2020/2021
  - Previous intention was to see the strategy in place at this time; delayed due to COVID
  - Meeting frequency changing to bi-monthly
  - The focus on agendas will be mostly strategy and strategy implementation
- 3. COVID-19 Economic Development Activities
  - Most projects put on hold; becoming more reactionary in our programming
