Location:

218 Paisley Street

Proposal:

The applicant is proposing to sever the rear portion of the subject property as a lot addition to the abutting property at 222 Paisley Street (file B-6/21, see attached). Due to the lot reconfiguration, the applicant is proposing a reduced lot area for the retained parcel. The lot area for the enlarged parcel (222 Paisley Street) is proposed to be 521 square metres.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. A variance from Table 5.1.2 Row 3 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law requires a minimum lot area of 460 square metres in the Residential Single Detached (R.1B) Zone.

Request:

The applicant is seeking relief from the By-Law requirements to permit a minimum lot area of 372 square metres.
