An Application for a Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

222 Speedvale Avenue East

Proposal:

The applicant is proposing to convert the use of the existing two-storey office building to a group home and to replace two (2) off-street parking spaces with a 101.3 square metre amenity area behind the existing building. A group home is defined as a place used for specialized or group accommodation for 4 to 8 residents under 24-hour supervision consistent with the requirements of its residents, but does not include a day care centre.

By-Law Requirements:

The property is located in the Specialized Office-Residential (OR-19) Zone. A variance from section 6.5.3.19.1.4 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law requires a minimum of 42 off-street parking spaces for 218-222 Speedvale Avenue East.

Request:

The applicant is seeking relief from the By-Law requirements to permit a minimum of 40 off-street parking spaces.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the remote public hearing. Instructions will also be provided during the hearing to ensure those watching the remote public hearing are given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 
