

An Application for a Minor Variance has been filed with the Committee of Adjustment

# **Application Details**

### Location:

222 Speedvale Avenue East

#### **Proposal:**

The applicant is proposing to covert the use of the existing two-storey office building to a group home and to replace two (2) off-street parking spaces with a 101.3 square metre amenity area behind the existing building. A group home is defined as a place used for specialized or group accommodation for 4 to 8 residents under 24-hour supervision consistent with the requirements of its residents, but does not include a day care centre.

### **By-Law Requirements:**

The property is located in the Specialized Office-Residential (OR-19) Zone. A variance from section 6.5.3.19.1.4 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law requires a minimum of 42 off-street parking spaces for 218-222 Speedvale Avenue East.

### **Request:**

The applicant is seeking relief from the By-Law requirements to permit a minimum of 40 off-street parking spaces.
