NATURE AND EXTENT OF RELIEF APPLIED FOR (variances required):

WE ARE APPLYING FOR RELIEF FOR THE SIDE YARD SETBACK FOR THE PROPOSED ATTACHED SINGLE GARAGE. ZONING BYLAW TABLE 5.1.2 ROW 7 REQUIRES A 1.5m SIDE SETBACK.

WE ARE REQUESTING A 0.6m SETBACK, EQUIVALENT TO WHAT IT WOULD BE FOR A DETACHED, ACCESSORY GARAGE.

Why is it not possible to comply with the provision of the by-law? (your explanation)

WE ATTEMPTED A DETACHED GARAGE BUT IT IS NOT PERMITTED BY THE GRCA DUE TO PROXIMITY TO THE SPEED RIVER. PLEASE SEE THE ENCLOSED SITE PLAN DATED SEPT. 25, 2020, WHICH WAS REJECTED BY GRCA.

SHIFTING THE GARAGE AWAY FROM THE RIVER REQUIRES IT TO BECOME ATTACHED TO THE HOUSE. BUT THE EXISTING HOUSE SIDE YARD SETBACK OF 4.35m DOES NOT LEAVE ENOUGH WIDTH FOR THE GARAGE AND A 1.5m SETBACK.
