Location:

63 Durham Street

Proposal:

The applicant is proposing to construct an addition to the existing detached dwelling which requires various minor variances (file A-54/20, see attached). An easement is required for the existing sanitary sewer lateral that runs from 48 Glasgow Street North through the subject property to the sanitary sewer in Durham Street. Part of the proposed addition will be constructed on the proposed easement, with the first floor consisting of a carport to allow access to the sanitary sewer lateral.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone.

Request:

The applicant proposes to create a 69 square metre easement with a width of 3.2 metres for the existing sanitary sewer lateral over a portion of the right side of 63 Durham Street in favour of 48 Glasgow Street North.
