An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

38 Hearn Avenue

Proposal:

The applicant is proposing to construct a 31 square metre single-storey building addition and a covered porch to the rear of the existing two-storey detached dwelling.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. Variances from Table 5.1.2 Row 7 and Table 4.7 Row 3 of Zoning By-law (1995)-14864, as amended, are being requested.

The By-law requires:

- a) a minimum side yard setback of 1.5 metres for 1 to 2 storey dwellings in an R.1B Zone; and
- b) a minimum side yard setback of 0.6 metres for an open, roofed porch not exceeding 1 storey.

Request:

The applicant is seeking relief from the By-Law requirements to permit:

- a) a minimum left side yard setback of 0.52 metres for the proposed one-storey building addition; and
- b) a minimum left side yard setback of 0.48 metres for the proposed one-storey open, roofed porch.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

confirmation and instructions for participating in the remote public hearing. Instructions will also be provided during the hearing to ensure those watching the remote public hearing are given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet.
