An Application for a Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

745 Stone Road East

Proposal:

The applicant is proposing to sever the rear portion of the subject property as a lot addition to the abutting property at 755 Stone Road East (file B-12/21, see attached). Due to the lot reconfiguration, the applicant is proposing a reduced rear yard setback for the retained parcel to permit the existing accessory buildings (Buildings 6 and 7, see attached). The lot area for the enlarged parcel (755 Stone Road East) is proposed to be 9,370 square metres.

By-Law Requirements:

The property is located in the Urban Reserve (UR) Zone. A variance from Section 11.2.3.4 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law requires that no accessory building or structure shall be located closer to any lot line than one-half building height [the height of building 7 is 4.5 metres; the height of building 6 is 3 metres] or 7.5 metres, whichever is greater.

Request:

The applicant is seeking relief from the By-Law requirements to permit a minimum rear yard setback of 1.19 metres for the existing accessory buildings.
