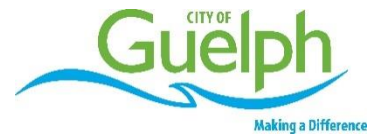


Committee of Adjustment Notice of Public Hearing



An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

60 Ontario Street

Proposal:

The applicant is proposing to maintain the existing 150 square metre commercial building and create three (3) commercial units for a proposed barber shop, coffee shop and convenience store.

By-Law Requirements:

The property is located in the Specialized Convenience Commercial (C.1-15) Zone. Variances from Sections 6.1.3.15.1 and 6.1.3.15.2 of Zoning By-law (1995)-14864, as amended, are being requested.

The By-law:

- a) permits a variety of uses in the C.1-15 Zone, but does not permit a personal service establishment, take-out restaurant and convenience store; and
- b) requires a minimum of 11 off-street parking spaces for the proposed coffee shop, barber shop and convenience store.

Requests:

The applicant is seeking relief from the By-Law requirements to permit:

- a) a personal service establishment, a take-out restaurant and a convenience store, as additional permitted uses; and
- b) a minimum of 0 off-street parking spaces.

Hearing Details

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

If you wish to speak to an application, please email or phone Committee of Adjustment staff no later than **12:00 p.m. on the day of the hearing**. Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the remote public hearing.

Instructions will also be provided during the hearing to ensure those watching the remote public hearing are given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. Notice of the Decision

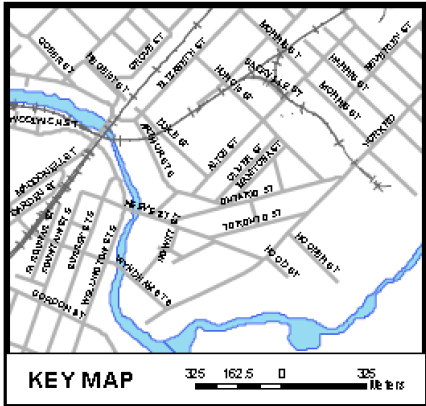
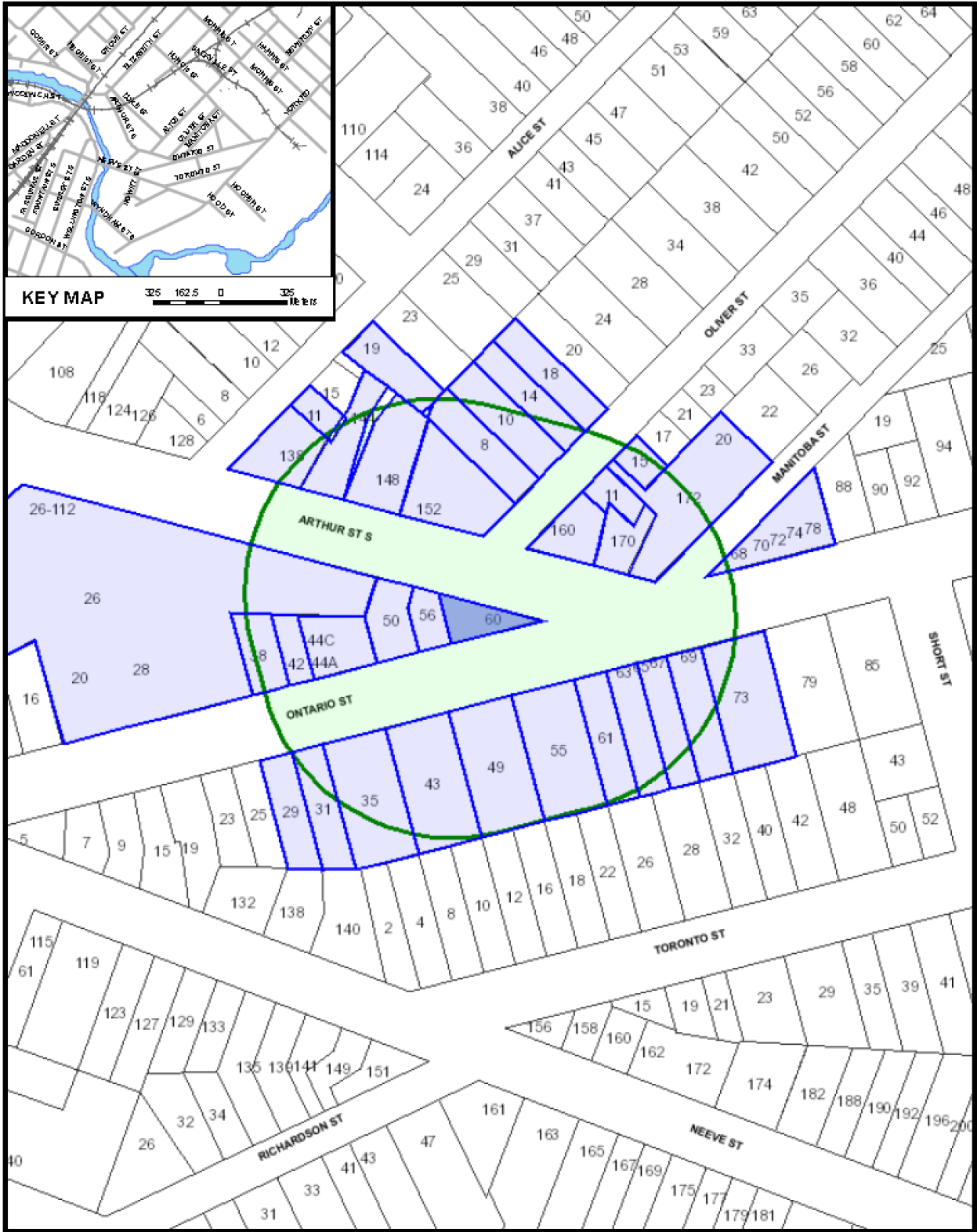
