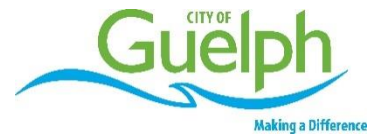


# Committee of Adjustment Notice of Public Hearing



**An Application for Consent [Lot Addition] has been filed with the Committee of Adjustment**

## Application Details

### Location:

745 Stone Road East

### Proposal:

The applicant is proposing to sever the rear portion of the subject property as a lot addition to abutting property at 755 Stone Road East. The applicant is also proposing to maintain the existing buildings on both parcels. Due to the lot reconfiguration, a minor variance application has been submitted (file A-27/21, see attached) to permit the retained parcel (745 Stone Road East) to have a reduced rear yard setback for the existing accessory buildings.

### By-Law Requirements:

The property is located in the Urban Reserve (UR) Zone.

### Request:

The applicant proposes to sever a parcel of land at the rear of 745 Stone Road East with an area of 1,375 square metres as a lot addition to the abutting property known as 755 Stone Road East. The retained parcel will have frontage along Stone Road East of 60.96 metres and an area of 3,273 square metres.

Written comments received by **May 6, 2021 at 12:00 p.m.** will be forwarded to the Committee members prior to the hearing. Comments submitted after this date will be provided at the hearing.

If you wish to speak to an application, please email or phone Committee of Adjustment staff no later than **12:00 p.m. on the day of the hearing.** Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the remote public hearing. Instructions will also be provided during the hearing to ensure those watching the remote public hearing are given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of

Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. The Notice of Decision will also explain the process for appealing a decision to the Local Planning Appeal Tribunal.

If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect to the proposed consent who has not made a written submission to the City of Guelph Committee of Adjustment or a verbal presentation to the Committee before it gives or refuses a provisional consent, the Local Planning Appeal Tribunal may dismiss the appeal.

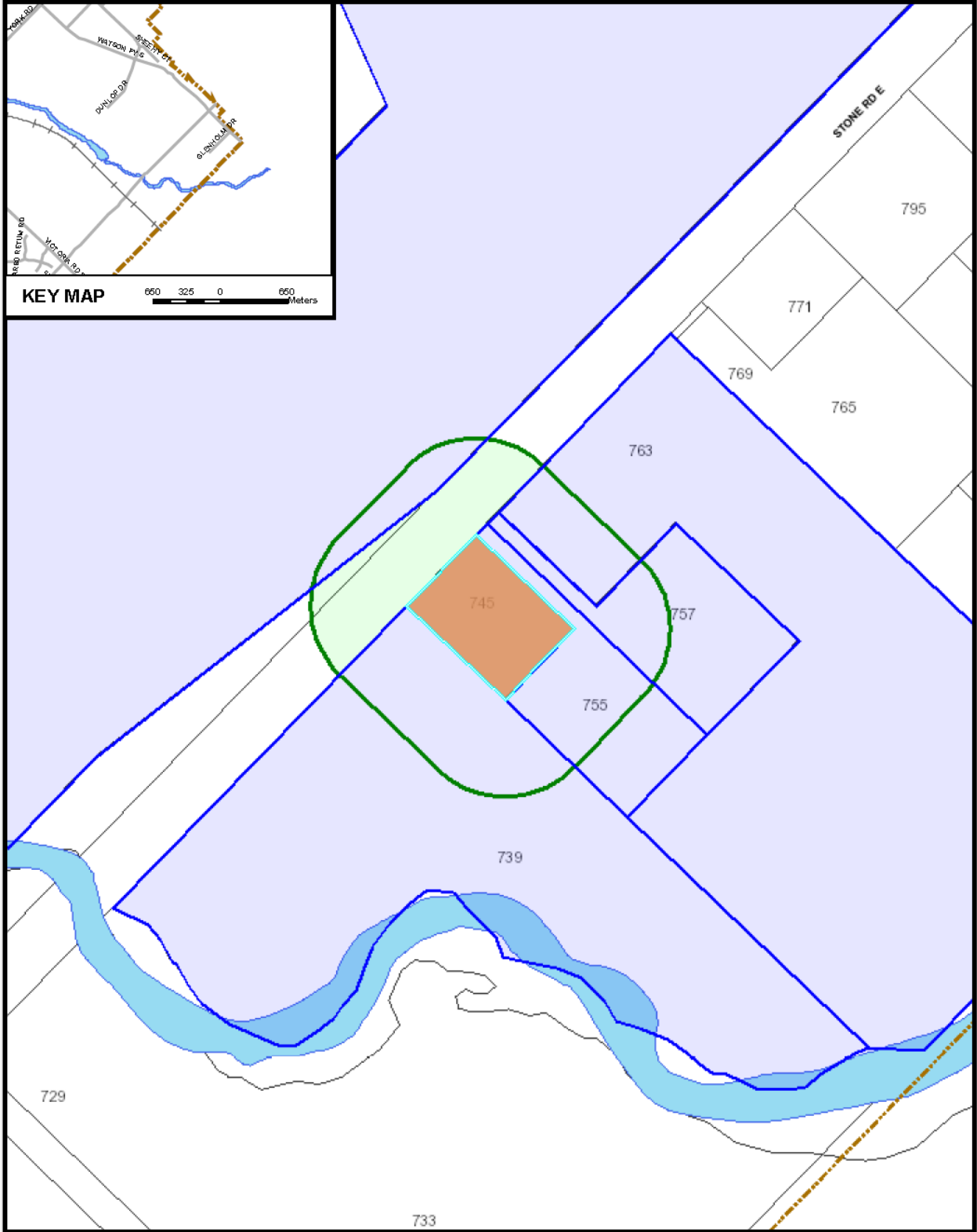
