It is a gem for our city to keep as much control over as possible. Guelph is unique in that we still have open space all around our city. The urban areas all around us are slowly being absorbed into bigger cities. It is essential to protect what open space we have and particularly one with so much history. Susan Ratcliff has told you about all the points of interest. As we have seen in this time of COVID-19, open space has been so essential for our physical and mental health. Please Assign Part 4 as well as part 5 to the designation of the OR lands as a Heritage Conservation District.

Please accept my comments regarding the proposed Notice of Intention to Designate for 785 York Road, known as the Yorklands property or the Ontario Reformatory property.

The Yorklands heritage property is a significant heritage property in Guelph and deserves the protection of designation under the Ontario Heritage Act. However, I hope Council listens to the expert advice of its professional Heritage staff instead of the well-intentioned but mis-informed recommendations of the municipal heritage advisory committee and Yorklands advocates.

I am a resident of Guelph and also a Heritage Planner - I am a full professional member of the Canadian Association of Heritage Professionals (and Past President of the Board of Directors), a registered professional planner and a member of the Canadian Institute of Planners. I have been working in the heritage planning field since 2004 and have been a full time heritage planner with the Town of Oakville since 2009. I have been working with cultural heritage landscapes since 2013 through the Town of Oakville's Cultural Heritage Landscape Strategy. These comments are my own professional opinion and submitted as a resident of the City of Guelph, not on behalf of my employer.

Designation under Part IV of the Ontario Heritage Act is completely sufficient to protect not just the buildings/structures on the Yorklands property, but also any landscape attributes that contribute to the cultural heritage value of the property. A Part V designation in addition to a Part IV designation is not necessary or required.

The Part V designation process requires substantial funding for the creation of a heritage district study, required public meetings and the creation of a heritage conservation district plan. In my personal experience, this process can take a year or more. Following the requirements of the Ontario Heritage Act, Council cannot simply designate an area under Part V without having followed the appropriate process and giving appropriate notice.

For examples of cultural heritage landscapes protected under Part IV of the Ontario Heritage Act (including buildings, structures and landscape features) designated by municipal government, I can point to several Oakville properties with information available on the Town's website: <u>https://www.oakville.ca/business/cultural-heritage-landscape-</u><u>strategy.html</u>. To date, I have been personally involved with at least 6 cultural heritage landscapes designated under Part IV of the Ontario Heritage Act.

Heritage district designation under Part V of the Ontario Heritage Act can be a very useful tool to conserve heritage properties. However, it is not 'better' than Part IV designation and is not the only tool that can be used to protect cultural heritage landscapes. Both forms of designation under the OHA conserve the cultural heritage value of properties and both require permission for alterations to manage change. In fact, Part IV designation provides the opportunity for municipalities to protect interior heritage attributes, whereas Part V designations do not.

I appreciate the efforts of the municipal heritage committee and those residents and volunteers supporting the conservation of the Yorklands property. Public support for heritage conservation is greatly needed and their advocacy for heritage protection is important. However, I have read the staff report and agree with the City of Guelph's Heritage Planner, Stephen Robinson, who has professional expertise with heritage legislation. A Part IV designation under section 29 of the Ontario Heritage Act is the most appropriate tool to protect the Yorklands heritage property.
