An Application for a Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

698-702 Woolwich Street

Proposal:

The applicant is proposing to construct a 511 square metre single-storey service commercial building at the rear of the lot. The property was subject to an application for Site Plan Approval (file SP10-C013) in 2011.

By-Law Requirements:

The property is located in the Specialized Service Commercial (SC.1-10) Zone. A variance from 6.4.3.1.10.1 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law permits a variety of uses in the SC.1-1 Zone, but does not permit a medical clinic, medical office, pharmacy or personal service establishment.

Due to minor variance decision file A-105/07, a financial establishment and vehicle establishment have been permitted as additional uses.

Request:

The applicant is seeking relief from the By-Law requirements to permit a medical clinic, medical office, pharmacy and personal service establishment as additional permitted uses.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the remote public hearing. Instructions will also be provided during the hearing to ensure those watching the remote public hearing are given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 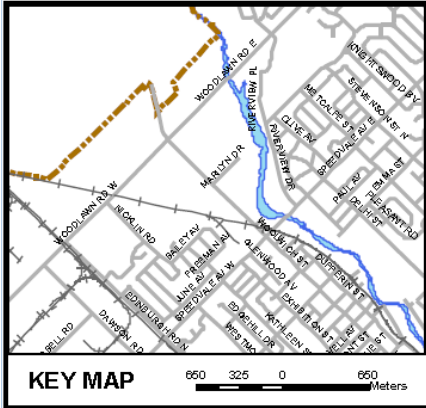
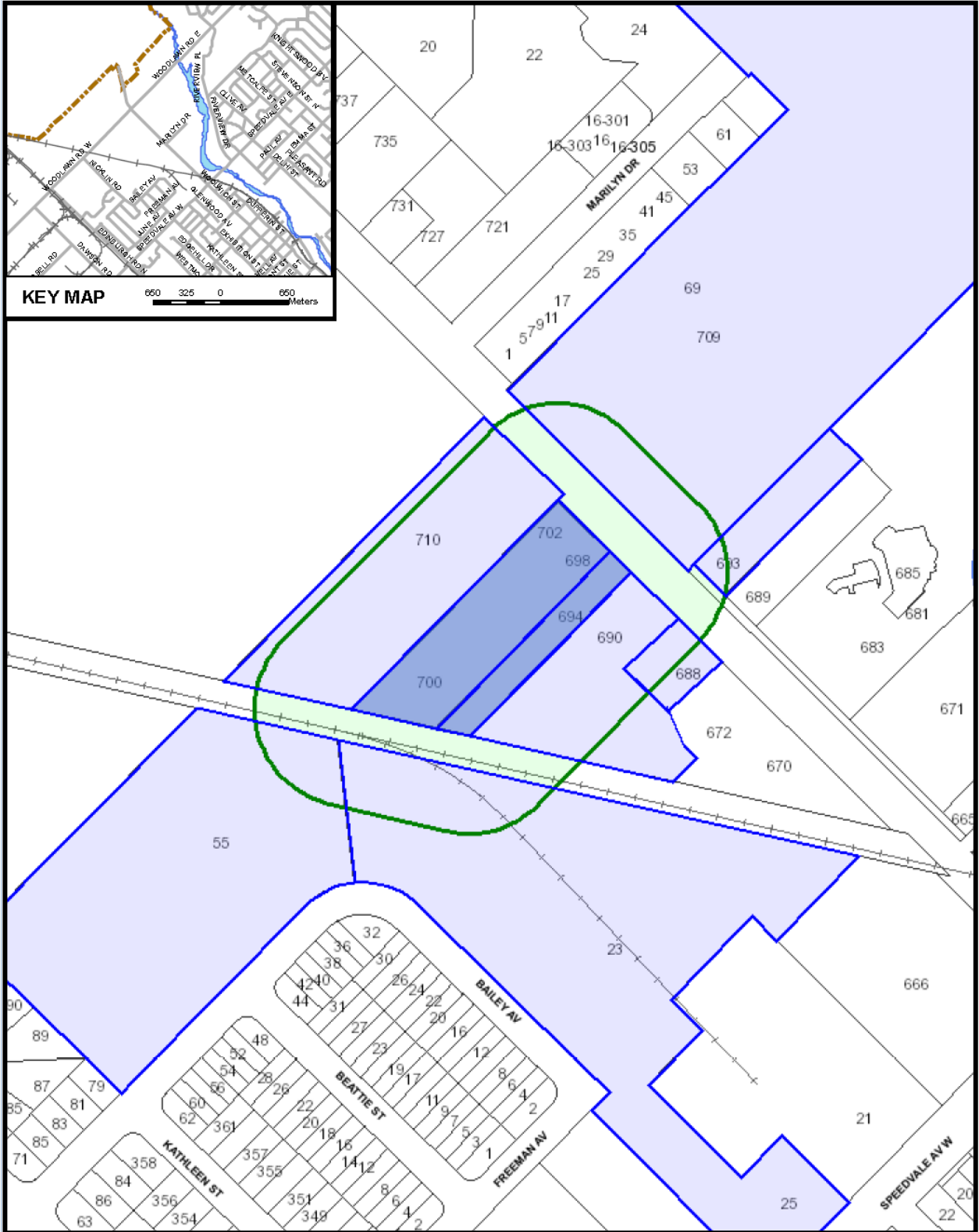
