Dear Mayor Guthrie and Councillors.

As a representative of the board of the Yorklands Green Hub I bring the community focus from our members to the former Ontario Reformatory lands which need your Heritage Conservation Designation that will support continued generational use of this site.

9 years ago, like many other Guelphites I had never been to this property. I knew about its novel history as a provincial institution for incarceration and reform of young men and as a major employer in this city for most of the last century. But I was contacted by Jack Milne from the Guelph Men's Club who had a vision for re-purposing this place as an educational and demonstration ecology hub to meet the challenges of future climate stress that is becoming a great challenge to all cities.

Our organization has delegated before and received your support, in principle, in 2014 and in 2019. We have endorsements from many organizations, businesses and institutions in our city. I want to quote from only a few to show you the breadth of interest that might help you see why we need the strongest possible heritage designation to guide the re-purposing of this property in the near future.

Over 8 years we have partnered with classes from University of Waterloo, Wilfred Laurier University and University of Guelph and worked with both school boards. We have led tours for Immigrant Services, history, geography and landscape architecture courses for their student research. We have delivered our Enviro- series to an engaged public. We continue to deliver our Polli-Patches , Noticing NatTure and Tall Trees program in the schools and the community . We currently are delivering our Foodster program off site at Sacred Heart CS grade 8 through the next few months.

The OR site was designed as a whole and the space with its trails offers mental and physical solace for hundreds of people each month. Being in this pastoral setting has supported the mental and physical health of returning veterans from Afghanistan, caregivers, families and people of all ages. It continues to bring tourists from the 100 miles around us to its uniqueness. This space can do so much to support the region in meeting severe climate stresses with resilience, communal strength and shared solutions. The legacy of this decision will be felt in perpetuity through protection of this site .
