## **Proposal:**

The applicant is proposing to sever the left portion of the subject property to create a new residential lot. The applicant is proposing to relocate the existing two-storey dwelling onto the proposed retained parcel and is proposing a new two-storey detached dwelling on the proposed severed parcel. Due to the proposed lot creation, related minor variance applications have been submitted for the proposed severed and retained parcels (files A-42/21 and A-43/21, see attached).

## **By-Law Requirements:**

The property is located in the Residential Single Detached (R.1B) Zone.

### **Request:**

The applicant proposes to sever a parcel of land with frontage along Oxford Street of 13.2 metres and an area of 443.1 square metres. The retained parcel will have frontage along Oxford Street of 13.5 metres and an area of 452.6 square metres.
