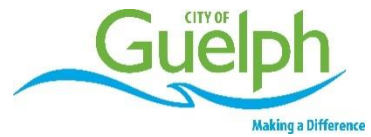


# Committee of Adjustment Notice of Public Hearing



**An Application for Minor Variances has been filed with the Committee of Adjustment**

## Application Details

### Location:

40 Extra Street

### Proposal:

The applicant is proposing to construct a 19 square metre deck surrounding a hot tub in the rear yard. The deck is proposed to be 0.5 metres above finished grade.

### By-Law Requirements:

The property is located in the Residential Single Residential (R.1B) Zone. Variances from Section 4.5.5.3 and Table 4.7 Row 1 of Zoning By-law (1995)-14864, as amended, are being requested.

The By-law requires:

- a) that every swimming pool or hot tub shall be located a minimum of 1.5 metres from any lot line, and any decking associated with the pool that is above 0.6 metres from finished grade, shall be located a minimum 1.5 metres from a lot line; and
- b) a minimum side yard setback of 0.6 metres for an uncovered porch not more than 1.2 metres above finished grade.

### Request:

The applicant is seeking relief from the By-Law requirements to permit:

- a) the proposed hot tub to be located 0.64 metres from the rear and right side lot lines; and
- b) the proposed uncovered porch (deck) to have a minimum rear yard setback and minimum right side yard setback of 0.14 metres.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request.
