

# Committee of Adjustment Notice of Public Hearing



**An Application for Consent [New Lot] has been filed with the Committee of Adjustment**

## Application Details

### Location:

29-31 Fountain Street West

### Proposal:

The applicant is proposing to sever the existing semi-detached dwelling to create separate ownership for each unit. An accessory residential dwelling unit is proposed within the basement of each semi-detached unit.

The property is also subject to a Zoning By-law Amendment (File OZS21-005) which was approved on September 13, 2021 to rezone the property to a Residential Semi-Detached/Duplex (R.2) Zone. File OZS21-005 is currently subject to a mandatory appeal period, which ends October 13, 2021.

### By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone.

### Request:

The applicant proposes to sever a parcel of land (29 Fountain Street West) with frontage along Fountain Street West of 8.9 metres and an area of 288 square metres. The retained parcel (31 Fountain Street West) will have frontage along Fountain Street West of 9.1 metres and an area of 293 square metres.

When we receive your request, we will send you confirmation and instructions for participating in the remote public hearing. Instructions will also be provided during the hearing to ensure those watching the remote public hearing are given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet.

If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect to the proposed consent who has not made a written submission to the City of Guelph Committee of Adjustment or a verbal presentation to the Committee before it gives or refuses a provisional consent, the Ontario Land Tribunal may dismiss the appeal.


