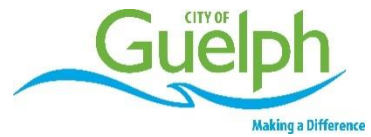


Committee of Adjustment Notice of Public Hearing



An Application for a Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

82 Woodlawn Road West

Proposal:

The applicant is proposing to use the existing building for on-site dog obedience training and dog training classes, along with the retail sale of related equipment and supplies. No outdoor use and no overnight animal boarding are proposed.

By-Law Requirements:

The property is located in the Highway Commercial (SC.2-4) Zone. A variance from Section 6.4.3.2.4.1 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law permits a variety of uses in the SC.2-4 Zone, but does not permit an animal boarding establishment. An animal boarding establishment is defined as a building, structure or part thereof, where dogs and cats and other domesticated animals, excluding livestock, are bred, raised, groomed, trained or kept for a fee on a temporary basis and may include overnight accommodation and outdoor facilities.

Request:

The applicant is seeking relief from the By-Law requirements to permit an animal boarding establishment as an additional permitted use on the subject property.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the remote public hearing. Instructions will also be provided during the hearing to ensure those watching the remote public hearing are given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. Notice of the Decision

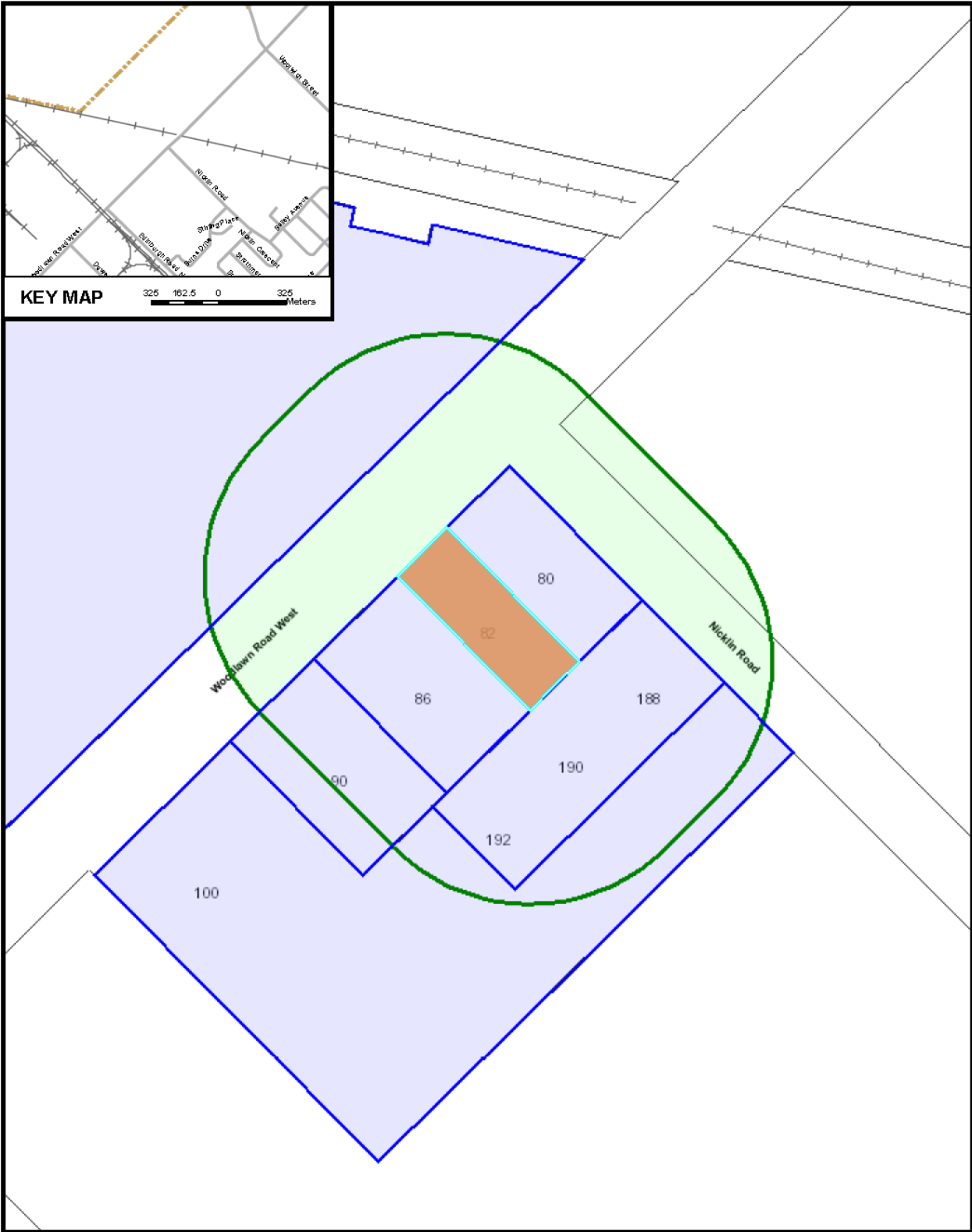
