#### 2. Call to Order

Mayor Guthrie called the meeting to order. (4:00 p.m.)

### 2.4 Disclosure of Pecuniary Interest and General Nature Thereof

There were no disclosures.

#### 3. 797 Victoria Road North

The following delegation spoke: Luke Weiler

Mayor Guthrie spoke regarding the Special City Council meeting which took place on September 30th, in particular, rules of motions to suspend sections of the City's Procedure By-law, reconsiderations of motions and requirements of a super majority, nine affirmative votes of Council, to suspend rules and reconsideration of motions. He provided an explanation of the incorrect reference in the displayed motion to suspend the rules at the September 30th meeting and the purpose of the October 6th meeting being to address the procedural error.

Stephen O'Brien, City Clerk, provided a summary of the procedure for Council's reconsideration of motions, the super majority vote requirements of nine affirmative votes for suspension of Procedure By-Law rules and reconsiderations, and recognized there was an incorrect reference in the displayed motion to suspend the rules at the September 30th Special City Council Meeting and he provided verbal clarification to Council at the September 30th meeting that nine affirmative votes were required to reconsider a motion. Mr. O'Brien stated that displayed motions are not the formal record of the actions of Council, but rather a tool to support Council's considerations and that, minutes are prepared based on the totality of the meeting and the rulings of the Chair. Mr. O'Brien stated that on September 30, the Chair declared that the vote count was seven-four, the motion to reconsider was defeated, as it did not meet the super majority requirements of nine votes and the minutes have been prepared based on the Chair's ruling at that meeting.

Mayor Guthrie clarified Mr. O'Brien's comments that section 5.8(g) was incorrectly referenced in the displayed motion to suspend the Procedure Bylaw rules, there now exists a discrepancy between the displayed motion and draft minutes prepared by the Clerk with the purpose of today's Special Meeting to address this discrepancy.

Mr. O'Brien provided a summary of the September 30th draft minutes which were posted to guelph.ca.

Scott Stewart, Chief Administrative Officer, provided confirmation on commitments made during the September 30 meeting to review staff procedures which took place relating to the 797 Victoria Rd. North item.

The Chair ruled that 7 votes are required for a majority vote and based on 13 members of Council.

Councillor Gibson raised a point of order and requested the Clerk display the motion for clarity.

The Chair ruled that motion before Council was to call the vote and the motion would not be displayed.
