## **Location:**

167 Alice Street

## **Proposal:**

The applicant is proposing to sever the property and create two new residential lots with one retained lot, which currently contains a detached dwelling.

This property was recently subject to an application for a Zoning By-law Amendment (file OZS19-006) and removal of Holding (H) provisions (file OZS20-010). Previous consent applications (Files B-12/20 and B-13/20) were conditionally approved at the October 8, 2020 Committee of Adjustment hearing but lapsed on October 14, 2021 due to the non-fulfilment of conditions.

## **By-Law Requirements:**

The property is located in the Residential Single Detached (R.1D) Zone.

#### **Requests:**

The applicant proposes the following as shown on the attached plan:

## File B-23/21 - Proposed Part 1

Severance of a parcel of land to create a new lot with frontage along Alice Street of 11 metres, a depth of 30.5 metres, and an area of 336 square metres.

#### File B-24/21 - Proposed Part 2

Severance of a parcel of land to create a new lot with frontage along Alice Street of 9 metres, a depth of 30.5 metres, and an area of 275 square metres.

The retained parcel (labelled as proposed part 3 on the attached reference plan) is proposed to have frontage along Alice Street of 21.03 metres and an area of 641 square metres.
