# Taking care of the community

# Taking care of the community

- Proof of vaccination or medical exemption
  - Required for visitors 12 years and older at high-risk indoor City facilities starting September.
  - Anyone under 18 participating in organized sports is exempt
  - Contract security staff are stationed outside entrances



# Taking care of the community

- The Corporate and Community Safety division has attended 65 calls for service and issued 10 charges in the last quarter.
- Unsanctioned gathering on September 25 at Chancellor's Way with 1,200 people resulted in:
  - 20 calls for Guelph-Wellington Paramedic Services
  - 300 calls to Guelph Police Services
  - 65 calls to City bylaw for noise complaints
  - 10 noise bylaw and nuisance party charges



# Taking care of the community

- Enhanced vaccine certificates
  - Announced by the Province on October 16 and available for download two days later
  - City facilities requiring proof of vaccination are using the Verify Ontario app to scan enhanced vaccine certificates at the door



# Taking care of the community

- Vaccinations
  - 90% of people 12 years and older are vaccinated!
- Guelph Wellington Paramedic Services continue to assist WDG Public Health to provide:
  - in-home vaccinations and testing for residents with limited mobility
  - vaccinations for residents in long-term care
  - tests for the local coroner on people who have passed away
  - in-home monitoring of COVID-19 patients



# Taking care of the community

- Our Food Future’s Grow Back Better campaign milestones:
  - \$1.6 million dollars in Infrastructure Canada funding to support the community relief effort
  - \$1.5 million in community donations and in-kind contributions
  - \$6.5 million in public and private sector funding leveraged

# Supporting Guelph businesses

- The seasonal patio program ended October 31.
  - 36 public patios downtown
  - 25 private patios
  
- Staff are working with Guelph Chamber of Commerce on amplifying the Guelph Shops message for the holidays
  - Guelph Shops wishbook
  - Local print and digital advertising
  - Launch of a Guelph Shops Instagram account



# Supporting economic recovery

- Phase one of the Tourism Recovery Initiative offers \$475,000 in funds available for two streams:
  - Operating expenses: rent, utilities, payroll
  - Physical and technological adaptation supports: patio beautification, safety modifications, digital upgrades



# Supporting economic recovery

- Phase two of the Tourism Recovery Initiative offers \$230,000 in funds to create:
  - Marketing campaigns to encourage locals and visitors to explore what Guelph has to offer
  - Food truck Tuesdays
  - Digital information kiosk



# Supporting Guelph businesses and economic recovery

- The City has granted \$178,700 in Emergency Grant funding to 18 organizations, unincorporated groups and individuals in the second phase of the 2021 granting process
- The deadline for the next round of applications closed November 8
- Recipients will be notified by the end of December 2021.

# Supporting our organization

- The COVID-19 Vaccination Policy has resulted in 94 per cent of City employees submitting proof of vaccination
- Mandatory testing for unvaccinated employees started October 18



# Supporting our organization

- Mayor Cam Guthrie announced plans to lift the City's state of emergency by December 31, if key conditions are met
- Quarterly reports of COVID-19 updates to Council will move to an 'as-needed' basis to coincide with lifting the City's state of emergency



# Financial implications and recovery

# Financial implications and recovery

- The City is projecting a year-end deficit of \$9.9 million before Safe Restart grant funding.
- Budget pressures are being experienced in Parking, Culture and Recreation, IT, Legal, Realty and Court Services and Guelph Transit.
- Some departments are projecting increased COVID-19 related operating expenses for cleaning, sanitization and personal protective equipment (PPE).



# Financial implications and recovery

- Significant supply chain volatility
- In some individual projects where budget has been reallocated or paused to re-evaluate scheduling, staff are seeing drastic increases to procurement costs beyond approved budgets
- Staff are monitoring this trend and may seek delegated authority from Council to use reserve funds within a procurement limit



# Recommendation
