

THE CORPORATION OF THE CITY OF GUELPH

By-law Number (2020) – 20472

Being a By-law to amend By-law Number (2002) – 17017 – the Traffic By-law (Through Highways in Schedule V, Yield Signs in Schedule VIII, Pedestrian Crossovers in Schedule X, No Parking in Schedule XV, No Stopping in Schedule XVI, Restricted Parking in Schedule XVII and 15 Minute / Public Loading Zones in Schedule XVIII)

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF GUELPH ENACTS AS FOLLOWS:

1. Schedule V of By-law Number (2002)-17017 is hereby deleted and replaced with the new Schedule V, attached hereto as Schedule “A”.
(To add Lemon Street, Metcalfe Street to Franklin Avenue; to add Lemon Street, Franklin Avenue to Winston Crescent; in the Through Highways Schedule)
2. Schedule VIII of By-law Number (2002)-17017 is hereby deleted and replaced with the new Schedule VIII, attached hereto as Schedule “B”.
(To remove Lemon St at Franklin Avenue, Lemon St; in the Yield Signs Schedule)
3. Schedule X of By-law Number (2002)-17017 is hereby deleted and replaced with the new Schedule X, attached hereto as Schedule “C”.
(To add London Road West at Kathleen Street and Kirkland Street; in the Pedestrian Crossovers Schedule)
4. Schedule XV of By-law Number (2002)-17017 is hereby deleted and replaced with the new Schedule XV, attached hereto as Schedule “D”.
(To add Crowe Street, south, Edinburgh Road South to McElderry Road, anytime; to add Gaw Crescent, east, 107m north of Periwinkle Way [south intersection] to 20m east thereof, anytime; to add Gaw Crescent, west, 107m north of Periwinkle Way [north intersection] to 20m west thereof, anytime; in the No Parking Schedule)
5. Schedule XVI of By-law Number (2002)-17017 is hereby deleted and replaced with the new Schedule XVI, attached hereto as Schedule “E”.
(To remove Lee Street, north, Cityview Dr to 30m east of Kearney St, 8:00am-4:30pm Mon-Fri; to remove Lee Street, south, Cityview Dr to 30m east of Kearney St, 8:00am-4:30pm Mon-Fri; to add Lee Street, north, Cityview Drive to 30m east of Kearney Street, 8:00am-4:30pm Mon-Fri September 1-June 30; to add Lee Street, south, Cityview Drive to 30m east of Kearney Street, 8:00am-4:30pm Mon-Fri September 1-June 30; in the No Stopping Schedule)
6. Schedule XVII of By-law Number (2002)-17017 is hereby deleted and replaced with the new Schedule XVII, attached hereto as Schedule “F”.
(To remove Gordon Street, east, City Laneway behind Farmers Market to Wilson Street, Authorized Vehicles Only Saturday; to remove Crimea Street, south, 91m west of C.N.R. crossing to 73m west thereof, anytime 2 hours; to add Crimea Street, south, 91m west of C.N.R. crossing to 41m west thereof, anytime 2 hours; to add Crimea Street, south, 132m west of C.N.R. crossing to 25m west thereof, anytime with signed disabled parking; in the Restricted Parking Schedule)
7. Schedule XVIII of By-law Number (2002)-17017 is hereby deleted and replaced with the new Schedule XVIII, attached hereto as Schedule “G”.
(To add Gordon Street, east, City Laneway behind Farmers Market to Wilson Street, 6am-1pm, Saturday; in the 15 Minute / Public Loading Zones Schedule)
8. Subject to Section 9, Sections 1, 2, 3, 4, 5, 6 and 7 of this By-law shall come into effect immediately.

9. No portion of this By-law shall come into effect until the part of the highway affected by it has all traffic control devices in place and is marked to comply with the signing requirements of the Ministry of Transportation of Ontario's Ontario Traffic Manuals.
10. This By-law is hereby adopted, amending Schedule V, VIII, X, XV, XVI, XVII and XVIII of By-law Number (2002)-17017 – the Traffic By-law.
