The City of Guelph has received a proposals to change the planning rules - the Official Plan and Zoning By-law at the corner of Vaughan Street and Gordon Street in order to construct a 9 storey, 98-unit apartment building. The land is designated in the Official Plan with multiple land use designations. Neighbourhood Commercial Centre use on the frontage, Medium Density Residential Use in the rear portion, and the entire site is within the 120 meter adjacent lands area of a Provincially Significant Wettand (PSW) - the Hanion Creek Swamp, Residents in the area vehemently oppose this proposal for a number of reasons teel primary to environmental and traffic impacts.
Firstly, the environmental impact is extremely concerning. An earlier preliminary six-kivery mixed-use apartment proposal at this six was rejected by the City partially due to concerns that the plan did not retain sufficient trees and landscaping along Yaughan Street but this new proposal has not addressed these concerns. They plan now is to renove all vegetation on the site which will result in the loss of nearly 200 trees, the majority of which have been listed as being in good condition. This is by no means an improvement on the previously rejected proposal and it would significantly impact the resources available to willder in this area.
Furthermore, the validity of the developer's environmental impact study is questionable. In the City of Guelph Guidelines for the preparation of Environmental Impact Studies, it is stated that "if the boundary of a wetland, including a provincially significant evaluator as required in the Guelph guidelines. Moreover, the environmental impact study does not appear to have been assessed by a certified evaluator as required in the Guel
