# The Corporation of the City of Guelph

## By-law Number (2022) - 20711

A By-law to amend By-law Number (2013)- 19529 as previously amended, being a By-law to delegate authority pursuant to the Municipal Act.

**Whereas** section 23.1(1) of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, authorizes a municipality to delegate its powers and duties subject to certain restrictions.

**And Whereas** The Corporation of the City of Guelph ("City of Guelph") adopted Bylaw Number (2013)-19529, as amended, being a By-law respecting the delegation of certain routine administrative and legislative powers and duties;

**And Whereas**, the City of Guelph now intends to amend By-law Number (2013)–19529 by adding a new Schedule "NN".

# The Council of the Corporation of the City of Guelph enacts as follows:

- 1. That the new Schedule "NN" as set out in Schedule 1 attached to this By-law be added to By-Law Number (2013)-19529.
- 2. In all other respects By-Law Number (2013)-19529, as previously amended remained unchanged.
- 3. This By-law shall come into force and take effect on April 25, 2022.

## Schedule "NN" By-law Number (2013)-19529 [added by By-law (2022)-20711]

Delegation of Authority to Delegate the Authority for the Issuance of letters of support for requests of winery, brewery and distillery owners for "By the Glass" Manufacturer's Limited Liquor Sales Licenses.

### **Definitions:**

- (a) "AGCO" means The Alcohol and Gaming Commission of Ontario
- (b) ""By the Glass" Manufacturer's Limited Liquor Sales License" has meaning ascribed to it by the AGCO;
- (c) "Liquor Licence Act" means the *Liquor Licence Act*. R.S.O. 1990, C. L. 19 as amended.
