# 2. Public Meeting to Hear Applications Under Sections 17, 34 and 51 of The Planning Act

## 2.1 Statutory Public Meeting Report - 12 Poole St. Proposed Official Plan Amendment File OZS22-002 - 2022-143

Lindsay Sulatycki, Senior Development Planner summarized the proposed Zoning By-law amendment application and presented the following items; location, existing Official Plan land use designation, purpose and effect of Official Plan amendment application, proposed official plan amendment, existing zoning, and proposed conceptual site plan.
