The Corporation of the City of Guelph

By-law Number (2022) - 20730

A by-law to repeal By-law (2022)-20722, and amend By-law (2022)-20698 – Traffic By-law, as amended, being a By-law to regulate the use of Highways within the City of Guelph and the Traffic and Parking thereon

The Council of the Corporation of the City of Guelph enacts as follows:

- 1. Schedule Y of Bylaw Number (2022) 20730 is hereby deleted and replaced with the new Schedule Y, attached here to as Schedule Y (To remove Woolwich Street, East, MacDonell to 119 meters north thereof, Anytime; in the No Parking Zones Schedule)
- 2. Schedule AA of Bylaw Number (2022) 20730 is hereby deleted and replaced with the new Schedule AA, attached here to as Schedule AA (To remove Woolwich Street (Highway located within downtown area), east, 119 meters north of Macdonell Street to 28 meters north thereof, 2 hours, 9am to 9pm, Monday to Saturday, once per day (5 hours, once per day within signed disabled parking spaces) on any Highway or combination of Highways indicated in Column A as being within the downtown area; To add Woolwich Street (Highway located within downtown area), east, Macdonell Street to 145 meters north thereof, 2 hours, 9am to 9pm, Monday to Saturday, once per day (5 hours, once per day within signed disabled parking spaces) on any Highway or combination of Highways indicated in Column A as being within the downtown area; in the Duration of Restricted Parking Zones Schedule)
- 3. Schedule EE of Bylaw Number (2022) 207030 is hereby deleted and replaced with the new Schedule EE, attached here to as Schedule EE (To add Wyndham Street North, West, Quebec Street to Woolwich Street; in the Permitted Angle Parking Zone Schedule)
- 4. Schedule C of Bylaw Number (2022) 20730 is hereby deleted and replaced with the new Schedule C, attached here to as Schedule C (To add Speedvale Avenue West at Imperial Road North, East, Left, Anytime; To add Speedvale Avenue West at Elmira Road North, West, Left, Anytime; in the Prohibited Turns Schedule)
- 5. Schedule K of Bylaw Number (2022) 20730 is hereby deleted and replaced with the new Schedule K, attached here to as Schedule K (To add Maltby Road East at Victoria Road South (both intersections); To add Centennial Road at College Heights Secondary School parking lot; in All-Way Stop Signs Schedule)
