New Legislation

Bill 109: More Homes for Everyone Act, 2022

- Aims to address housing shortages by mandating municipalities to expedite approvals to build homes faster.
 - Requires municipalities to partially refund zone change application fees and site plan application fees if decisions are not made within 90 days.

Bill 23: More Homes Built Faster Act, 2022

- Introduces municipal housing targets based on population size and growth.
- Provincial goal is to build 1.5 million homes in 10 years.
 - City of Guelph has been assigned a housing target of 18,000 by 2032.
- To meet this target, the bill proposes to exempt developers from paying development charges, parkland dedication fees and community benefit charges.

Administrative impacts for municipalities

- Site Plan Applications must be approved 60 days from the day they are submitted
 - Approval delays have implications for the municipality that impact fees collected from the applicant.
 - There are 3 delay points with the maximum being 100% of fees refunded to the applicant if no approval is received within 120 days.
- The Planning Act has been amended to support applicants in this process.

Departmental impacts of new legislation: Two categories of comments

Required comments:

Comments must be supported by law:

- Federal
- Provincial
- By-laws

Recommended comments:

Comments are for consideration by the applicant.

Accessibility impacts of new legislation

Required comments:

- Accessibility-related requirements come from the Accessibility for Ontarians with Disabilities Act (AODA) – Design of Public Spaces (DOPS) Standards.
- For new and existing facilities, owned, leased or operated by the City of Guelph – requirements come from the AODA DOPS and the Facility Accessibility Design Manual (FADM)

Recommended comments:

 Accessibility-related recommendations come from the FADM, AAC review feedback and other related best-practices

Changes to the AAC review process: Non-City development applications

Before the Provincial legislation

- A. AAC/Accessibility recommendations were brought forward to the applicant
- B. FADM was used as a supporting document as it includes the AODA requirements
- C. Unmet recommendations were escalated rarely happened
- D. Otherwise, recommendations were met

Now – Working within the Provincial legislation

- A. AAC/Accessibility AODA supported comments are brought forward to the applicant
- B. AAC/Accessibility and FADM supported comments are recommendations if beyond the AODA
- C. Unmet requirements will be escalated
- D. Requirements are expected to be met

- Industrial use site plans
- Commercial use site plans
- Multi-residential use site plans
