

Committee of Adjustment Notice of Public Hearing



Applications for minor variance have been filed with the Committee of Adjustment

Application Details

Location:

26 Forest Street

Proposal:

The applicant is proposing to sever the property and create two new residential lots and one retained residential lot (files B-3/23 and B-4/23, see attached). Due to the lot reconfiguration, minor variance applications are required to allow for reduced lot frontages for the severed and retained lots.

This property was previously subject to a consent application to create a new lot (file B-5/22) and a minor variance application to permit reduced lot frontage (file A-9/22). These applications were approved by the Committee of Adjustment on March 10, 2022 and then subject to an appeal which was withdrawn.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. Variances from Section 5.1.2 Row 4 of Zoning By-law (1995)-14864, as amended, are being requested.

The By-law requires a minimum lot frontage of 15 metres for properties located in the R.1B Zone.

Request:

The applicant is seeking relief from the By-Law requirements to permit:

File A-14/23

- a) a minimum lot frontage of 11.9 metres for the proposed severed parcel (shown as minor variance request A on the attached site sketch).

File A-15/23

- a) a minimum lot frontage of 11.9 metres for the proposed severed parcel (shown as minor variance request B on the attached site sketch).

File A-16/23

- a) a minimum lot frontage of 11.9 metres for the proposed retained parcel (shown as minor variance request C on the attached site sketch).
