The Corporation of the City of Guelph

By-law Number (2023) - 20780

A by-law to repeal By-law (2023) – 20768, and amend By-law (2022) – 20698 – Traffic By-law, as amended, being a By-law to regulate the use of Highways within the City of Guelph and the Traffic and Parking thereon

The Council of the Corporation of the City of Guelph enacts as follows:

- 2. Schedule H of By-law Number (2022) 20698 is hereby deleted and replaced with the new Schedule H, attached here to as Schedule H (To add Gordon Street at Maltby Road; in the Traffic Control Signals Schedule)
- 3. Schedule O of By-law Number (2022) 20698 is hereby deleted and replaced with the new Schedule O, attached here to as Schedule O (To remove Paisley Road, Imperial Road to the western City limits, 60 km/h; to remove Clair Road West, Gordon Street to Clairfields Drive, 60 km/h; to remove Watson Road, Watson Parkway North to Watson Parkway South, 60 km/h; to remove Watson Parkway North, Northern City limits to Eastview Road, 60 km/h; to remove Gordon Street, Clair Road to the southern City limits, 70 km/h; to remove Gordon Street, 100 metres south of Hands Drive to Clair Road, 60 km/h; to remove Waterloo Avenue, Guelph Montessori School elementary school zone, 40 km/h when flashing, 8am to 9am and 3pm to 4pm; to remove Scottsdale Drive, Ecole St. Rene Goupil School elementary school zone, 40 km/h when flashing, 8am to 9am and 3pm to 4pm; to remove Scottsdale Drive, Priory Park Public School elementary school zone, 40 km/h when flashing, 8am to 9am and 3pm to 4pm; to remove Watson Parkway, 24 metres south of Watson Road to Stone Road East, 60 km/h; to add Winston Crescent, John Galt Public School elementary school zone, 30 km/h; to add Watson Parkway South, York Road to Stone Road East, 60 km/h; to add Waterloo Avenue, Edinburgh Road South to

Gordon Street/Norfolk Street, 40 km/h; to add Norfolk Street, Waterloo Avenue/Wilson Street to Norwich Street, 40 km/h; to add Gordon Street, Stone Road to Waterloo Avenue/Wilson Street, 40 km/h; to add Gordon Street, Clair Road to the southern City limits, 60 km/h; to add Wellington Street, 106 metres west of McCrae Boulevard to Macdonell Street, 40 km/h; to add College Avenue, Edinburgh Road South to Dundas Lane, 40 km/h; to add Watson Parkway North, Northern City limits to Couling Crescent (north intersection), 60 km/h; to add Watson Road, York Road to Watson Parkway South, 60 km/h; to add Woolwich Street, Norwich Street to Macdonell Street, 40 km/h; to add Woolwich Street, Marilyn Drive to Speedvale Avenue, 40 km/h; to add Imperial Road North, Speedvale Avenue East to Willow Road, 40 km/h; in the Speed Limits Schedule)

- 5. Schedule Q of By-law Number (2022) 20698 is hereby deleted and replaced with the new Schedule Q, attached here to as Schedule Q (To add Winston Crescent, Bennett Avenue to Metcalfe Street, Anytime; to add Waterloo Avenue, Edinburgh Road South to Gordon Street/Norfolk Street, anytime; in the Community Safety Zones Schedule)
- 6. Subject to Section 7, Section 1, 2, 3, 4 and 5 of this By-law shall come into effect immediately.
- 7. No portion of this By-law shall come into effect until the part of the Highway affected by it has all traffic control devices in place and is marked to comply with the signing requirements of the Ministry of Transportation of Ontario's Ontario Traffic Manuals.
- 8. This By-law is thereby adopted, amended Schedules C, H, J, O and Q of By-law Number (2022) 20698 the Traffic By-law.
