An application for consent [new lots] has been filed with the Committee of Adjustment

Application Details

Location:

26 Forest Street

Proposal:

The applicant is proposing to sever the property and create two new residential lots and one retained residential lot. The applicant is proposing to demolish the existing detached dwelling and construct detached dwellings on the proposed severed and retained lands. Due to the lot reconfiguration, minor variance applications have been submitted (files A-14/23, A-15/23 and A-16/23, see attached).

This property was previously subject to a consent application to create a new lot (file B-5/22) and a minor variance application to permit reduced lot frontage (file A-9/22). These applications were approved by the Committee of Adjustment on March 10, 2022 and then subject to an appeal which was withdrawn.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone.

Request:

The applicant proposes the following, as shown on the attached sketch:

The applicant proposes to sever a parcel of land with frontage along Forest Street of 11.9 metres and an area of 614 square metres.

File B-4/23

The applicant proposes to sever a parcel of land with frontage along Forest Street of 11.9 metres and an area of 614 square metres.

The retained parcel will have frontage along Forest Street of 11.9 metres and an area of 614 square metres.

Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect to the proposed consent does not make written submissions to the City of Guelph Committee of Adjustment before it gives or refuses to give provisional consent, the Ontario Land Tribunal may dismiss the appeal.

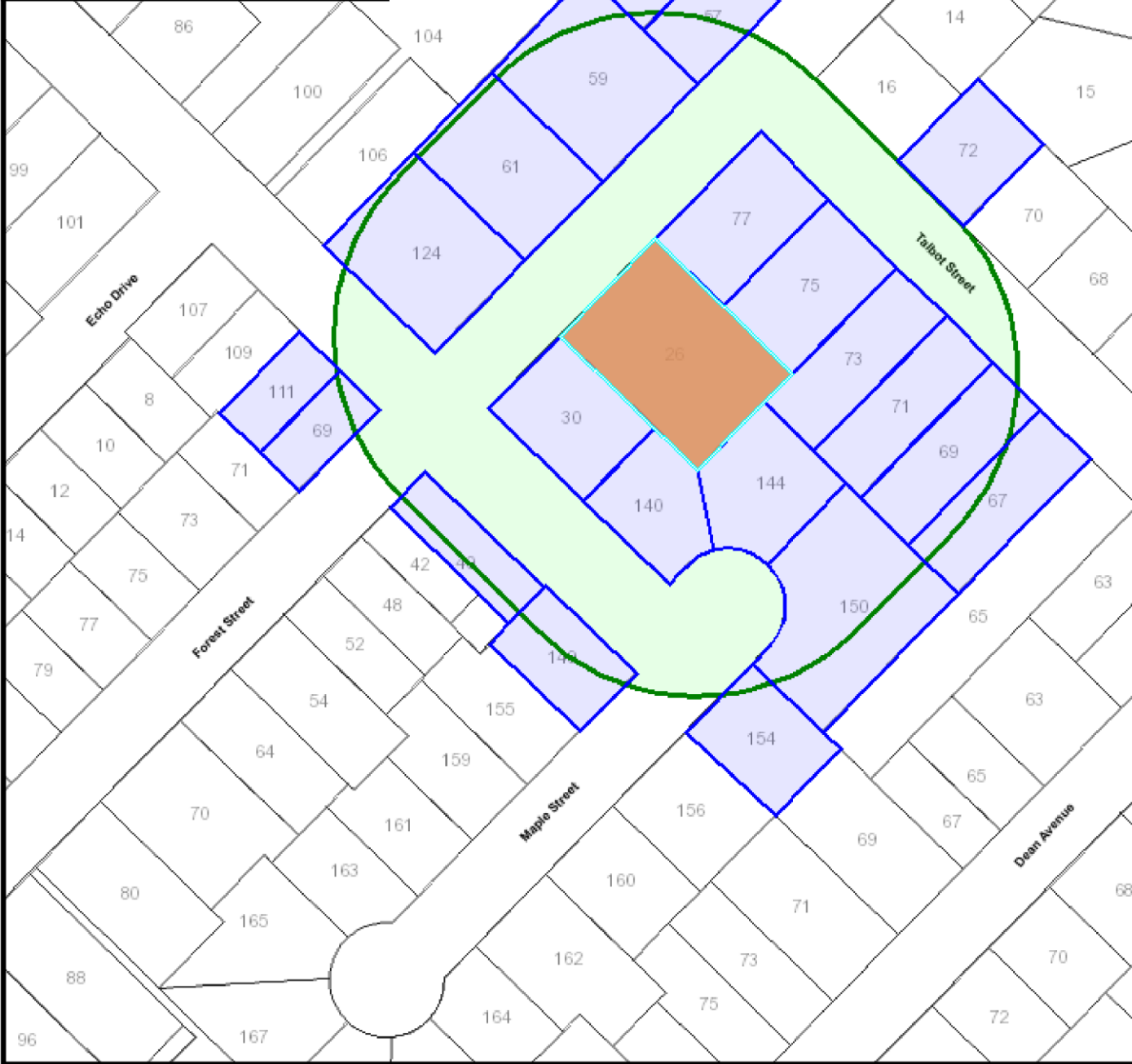
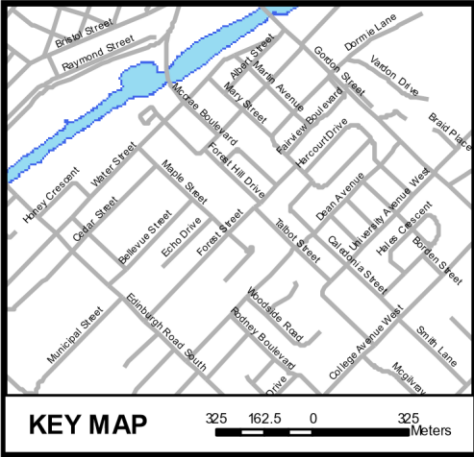
