**An application for consent [new lot] has been filed with the Committee of Adjustment**

## Application Details

### Location:

900 Southgate Drive

### Proposal:

The applicant is proposing to sever part of the subject property to create a new industrial lot, which is proposed to contain a new industrial building. The existing industrial building on the retained lands is proposed to remain.

### By-Law Requirements:

The property is located in the Specialized Industrial (B.1-2) Zone.

### Request:

The applicant proposes to sever a parcel of land with frontage along Clair Road West of 199.1 metres and an area of 25,000 square metres. The retained parcel is proposed to have frontage along Southgate Drive of 408.5 metres and an area of 150,000 square metres.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect to the proposed consent does not make written submissions to the City of Guelph Committee of Adjustment before it gives or refuses to give provisional consent, the Ontario Land Tribunal may dismiss the appeal.


