### **Proposal:**

The applicant is proposing to maintain the location of the addition at the rear of the existing dwelling.

## **By-Law Requirements:**

The property is located in the Specialized Residential Single Detached (R.1C-3) Zone. A variance from Table 5.1.2 Row 7 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law requires that the minimum side yard setback for a dwelling in the R.1C Zone be 1.2 metres.

## **Request:**

The applicant is seeking relief from the By-Law requirements to permit a minimum right side yard setback of 0.22 metres for the addition at the rear of the existing dwelling.
