

# **The Corporation of the City of Guelph**

## **By-law Number (2023) - 20785**

A by-law to repeal By-law (2022) – 20780, and amend By-law (2022) – 20698 – Traffic By-law, as amended, being a By-law to regulate the use of Highways within the City of Guelph and the Traffic and Parking thereon

### **The Council of the Corporation of the City of Guelph enacts as follows:**

1. Schedule C of By-law Number (2022) – 20698 is hereby deleted and replaced with the new Schedule C, attached here to as Schedule C (To add Speedvale Avenue West at Silvercreek Parkway North, East, Left, Anytime; to add Speedvale Avenue West at Dawson Road, East, Left, Anytime; to add Speedvale Avenue West at Edinburgh Road North, East, Left, Anytime; in the Prohibited Turns Schedule)
2. Schedule J of By-law Number (2022) – 20698 is hereby deleted and replaced with the new Schedule J, attached here to as Schedule J (To remove Balsarroch Place at Armstrong Avenue, Balsarroch Place; to remove Cote Drive at Skov Crescent, Cote Drive; to remove Kirsten Drive at Pleasant Road, Kirsten Drive; to remove Orchard Crescent at Callander Drive, Orchard Crescent; to remove Howitt Street at Margaret Street, Howitt Street [eastbound]; to remove Wolfond Crescent at Forest Street, Wolfond Crescent; to remove Walter Street at Empire Street, Walter Street; to remove Hayes Avenue at Beverley Street, Hayes Avenue; to remove Shirley Avenue at Bennett Avenue, Shirley Avenue; to remove Franklin Avenue at Bennett Avenue, Franklin Avenue; to remove Franklin Avenue at Winston Crescent, Franklin Avenue; to remove Shirley Avenue at Erin Avenue, Shirley Avenue; to remove Cadillac Drive at Shirley Avenue, Cadillac Drive; to remove Erin Avenue at Lane Street, Erin Avenue; to remove Lane Street at Bennett Avenue (north intersection), Bennett Avenue; to remove Lincoln Crescent at Laverne Avenue, Lincoln Crescent; in the Yield Right of Way Signs Schedule)
3. Subject to Section 4, Section 1 and Section 2 of the By-law shall come into effect immediately.
4. No portion of this By-law shall come into effect until the part of the Highway affected by it has all traffic control devices in place and is marked to comply with the signing requirements of the Ministry of Transportation of Ontario's Ontario Traffic Manuals.
5. This By-law is thereby adopted, amended Schedule C and Schedule J of By-law Number (2022) – 20698 – the Traffic By-law.
