Proposal:

The applicant is proposing to sever part of the subject property to create one new residential lot and one retained residential lot. The applicant is proposing to retain the existing dwelling on the proposed retained lands and remove the existing attached garage. A new detached dwelling is to be constructed on the proposed severed lands. Due to the lot reconfiguration, a minor variance application has been submitted for the retained lot (file A-25/23, see attached).

Request:

The applicant proposes to sever a parcel of land with frontage along Lynwood Avenue of 15.5 metres and an area of 469 square metres. The retained parcel is proposed to have frontage along Edinburgh Road South of 22.4 metres and an area of 877 square metres.
