My name is Greg Davidson, and I am reaching out today to express my support of the proposed updates to bylaw Section 4.15 related to Home Occupations which allow additional dwellings and accessory buildings to be utilized for Home Occupations.

I have been a resident of the City Guelph for over 20 years, having spent a large part of my youth here, attended the University of Guelph, worked professionally within the community, and now as a parent of a young child I'm actively aware and invested in City decisions that can have an impact to help our community evolve, develop, and create for our current and future generations. I have witnessed the development within this City, from the new Quebec Street Mall to the construction of the new City Hall, Downtown improvements, and the new industrial park in the south end of the city.
