## **Application Details**

#### Location:

77 Foster Avenue

#### **Proposal:**

The applicant is proposing to construct a third-storey addition to the existing residential dwelling on the subject property.

## **By-Law Requirements:**

The property is located in the Residential Single Detached (R.1B) Zone. A variance from Table 5.1.2 Row 7 and Section 5.1.2.8 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law requires a minimum side yard setback of 1.5 metres for a dwelling over two-storeys located within Defined Area Map Number 66 of the By-Law.

#### **Request:**

The applicant is seeking relief from the By-Law requirements to permit a minimum left side yard setback of 0.56 metres for the existing dwelling and the proposed third-storey addition.
