An Application for Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

8 Lynwood Avenue

Proposal:

The applicant is proposing to sever the property and create one new residential lot and one retained residential lot (file B-5/23, see attached). Due to the lot reconfiguration, a minor variance application is required to allow for a reduced rear yard setback for the proposed retained lot.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. A variance from Table 5.1.2 Row 8 of Zoning By-law (1995)-14864, as amended, is being requested.

The By-law requires that the minimum rear yard setback be 7.5 metres or 20% of the lot depth [being 6.7 metres], whichever is less, for a dwelling located in the R.1B Zone.

Request:

The applicant is seeking relief from the By-Law requirements to permit a minimum rear yard setback of 2 metres for the existing dwelling on the retained parcel.

Hearing Details

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. 
