

Committee of Adjustment Notice of Public Hearing



An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

70 Lyon Avenue

Proposal:

The applicant is proposing to demolish the existing second storey of the dwelling and construct a new second storey addition along with new exterior basement stairs in the front yard.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. Variances from Table 5.1.2 Row 6 and Table 4.7 Row 12 of Zoning By-law (1995)-14864, as amended, are being requested.

The By-law requires:

- a) a minimum front yard setback of 6 metres for a single detached dwelling located in the R.1B Zone; and
- b) exterior stairs to project a maximum of 1.5 metres into the required front yard.

The property is also located in the Low Density Residential 1 (RL.1) Zone. Variances from Table 6.3 and Table 4.1 Row 7 of Zoning By-law (2023)-20790, as amended, are being requested.

The By-law requires:

- a) a minimum front yard setback of 6 metres; and
- b) exterior stairs to project a maximum of 1.5 metres into the required front yard.

Request:

The applicant is seeking relief from the requirements of both By-Laws to permit:

- a) a minimum front yard setback of 4.76 metres for the proposed second storey addition to the existing dwelling; and
- b) the proposed stairs to have a maximum projection of 2.74 metres into the required front yard.

Hearing Details

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. 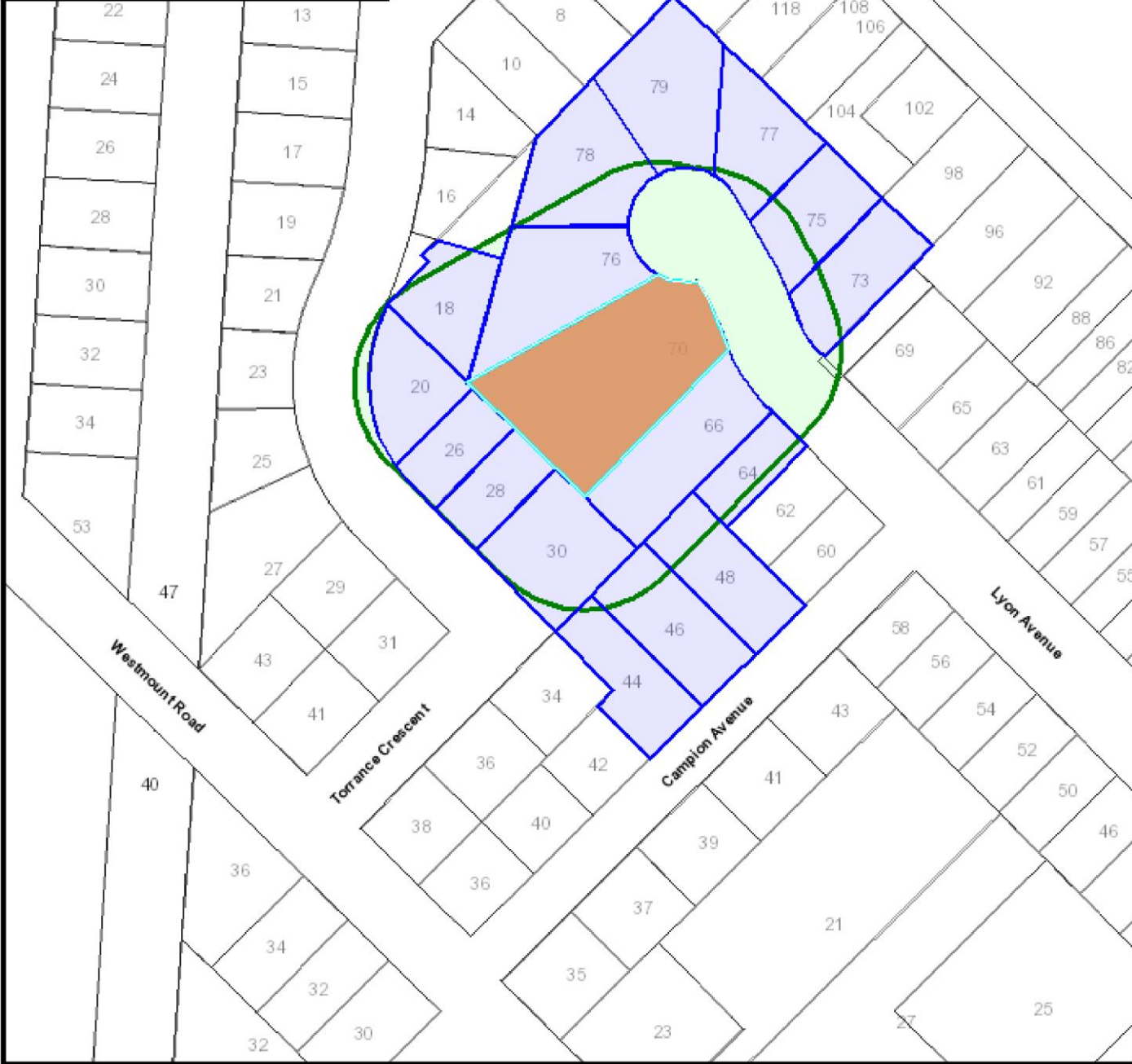
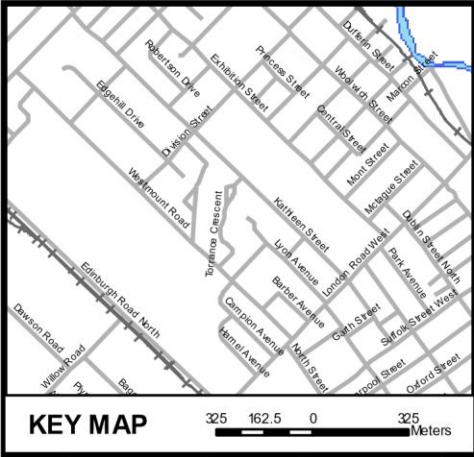
