

# Committee of Adjustment Notice of Public Hearing



**An application for consent [new lot] has been filed with the Committee of Adjustment**

## Application Details

### Location:

51 Hazelwood Drive

### Proposal:

The applicant is proposing to sever part of the subject property to create one new residential lot and one retained residential lot. The applicant is proposing to retain the existing dwelling on the proposed retained lands and remove the existing attached garage. A new detached dwelling is to be constructed on the proposed severed lands.

### By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone, according to Zoning By-law (1995)-14864, as amended. The property is also located in the Low Density Residential 1 (RL.1) Zone, according to Zoning By-law (2023)-20790, as amended.

### Request:

The applicant proposes to sever a parcel of land with frontage along Hazelwood Drive of 17.78 metres and an area of 956.9 square metres. The retained parcel is proposed to have frontage along Hazelwood Drive of 35.56 metres and an area of 1913.8 square metres.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet.

If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect to the proposed consent does not make written submissions to the City of Guelph Committee of Adjustment before it gives or refuses to give provisional consent, the Ontario Land Tribunal may dismiss the appeal.

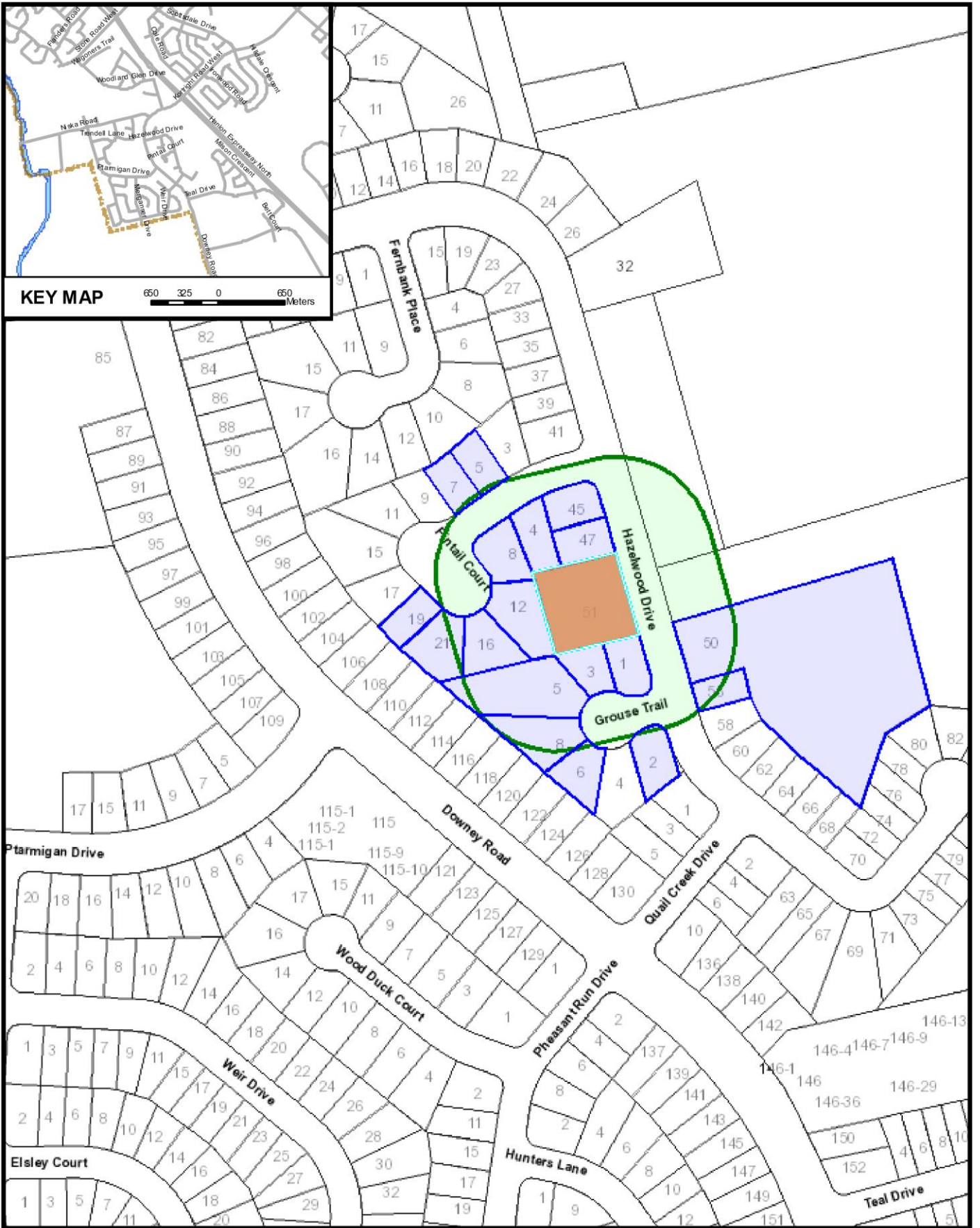
