An Application for Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

512 Woolwich Street

Proposal:

The applicant is proposing to establish a medical clinic in a unit of the existing commercial building.

By-Law Requirements:

The property is located in the Specialized Office-Residential (OR-37) Zone. A variance from Section 6.5.3.37.1 of Zoning By-law (1995)-14864, as amended, is being requested. The By-law permits a variety of uses in the OR-37 Zone, including a medical clinic, provided it does not exceed 464.5 square metres of gross floor area.

The property is also located in the Site-Specific Convenience Commercial (CC-3) Zone. A variance from Section 18.12.3 of Zoning By-law (2023)-20790, as amended, is being requested. The By-law permits a variety of uses in the CC-3 Zone, but does not permit a medical clinic use.

Request:

The applicant is seeking relief from the requirements of both By-laws to permit a medical clinic use with a maximum gross floor area of 1171 square metres as an additional permitted use on the subject property.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 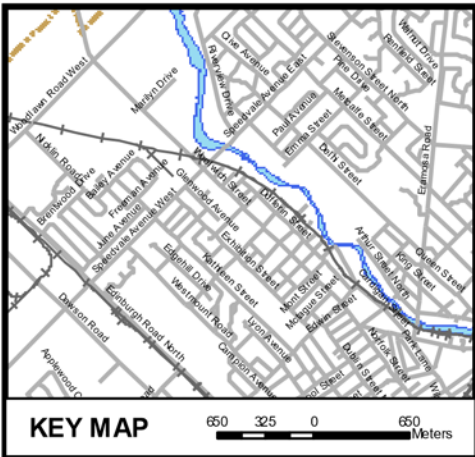
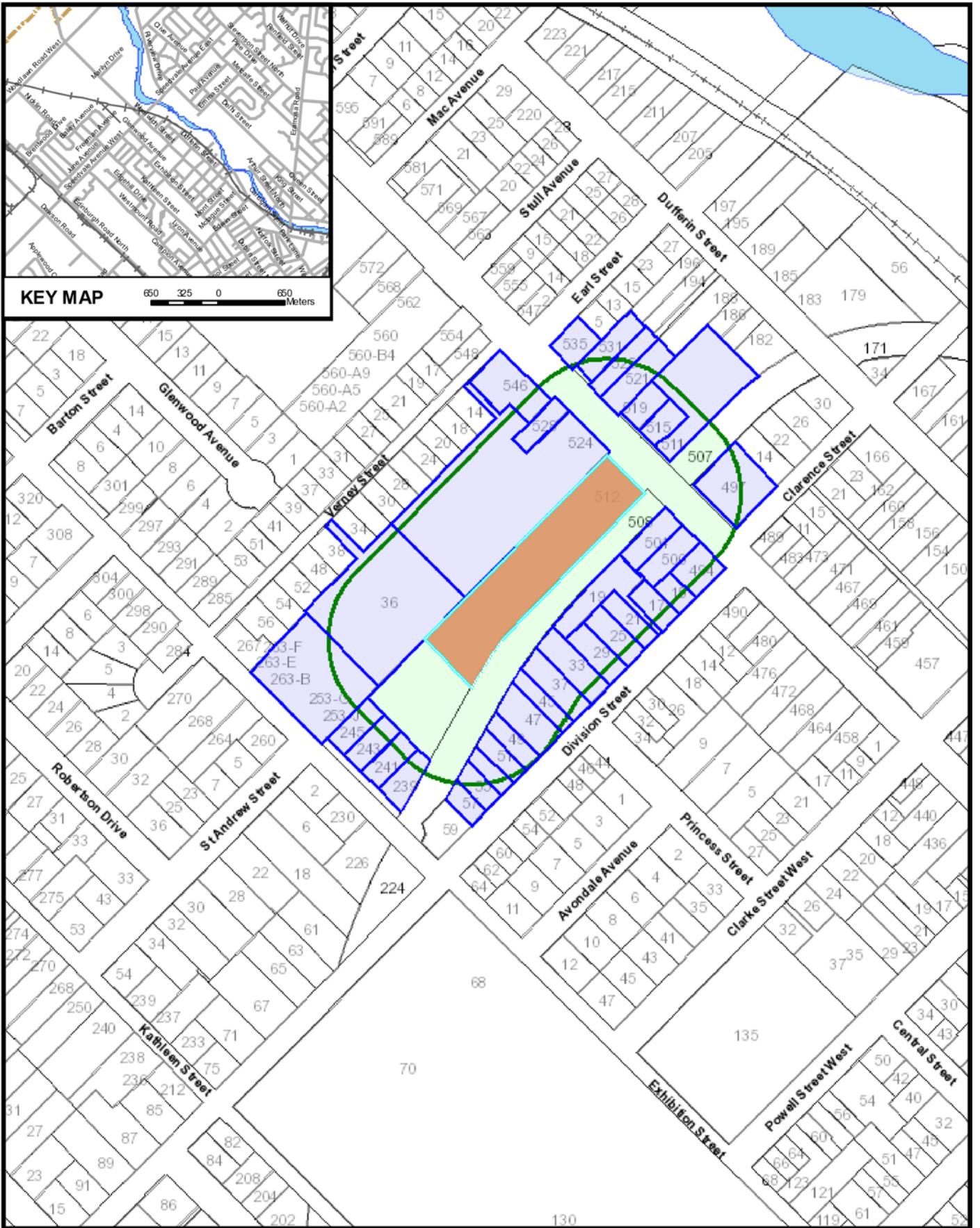
