An Application for Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

261 Arthur Street North

Proposal:

The applicant is proposing to construct a second storey rooftop deck with exterior stairs at the rear of the existing dwelling.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. A variance from Table 4.7 Row 2 of Zoning By-law (1995)-14864, as amended, is being requested. The By-law requires an uncovered porch more than 1.2 metres above finished grade, to be no higher than the main floor/entry level of the dwelling.

The property is also located in the Low Density Residential 1 (RL.1) Zone. A variance from Section 4.7.7 of Zoning By-law (2023)-20790, as amended, is being requested. The By-law requires an uncovered porch more than 1.2 metres above finished grade, to be no higher than the main floor/entry level of the dwelling.

Request:

The applicant is seeking relief from the requirements of both By-laws to permit the proposed uncovered porch to be 3.35 metres above finished grade, exceeding the height of the main floor entry level of the dwelling.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet.

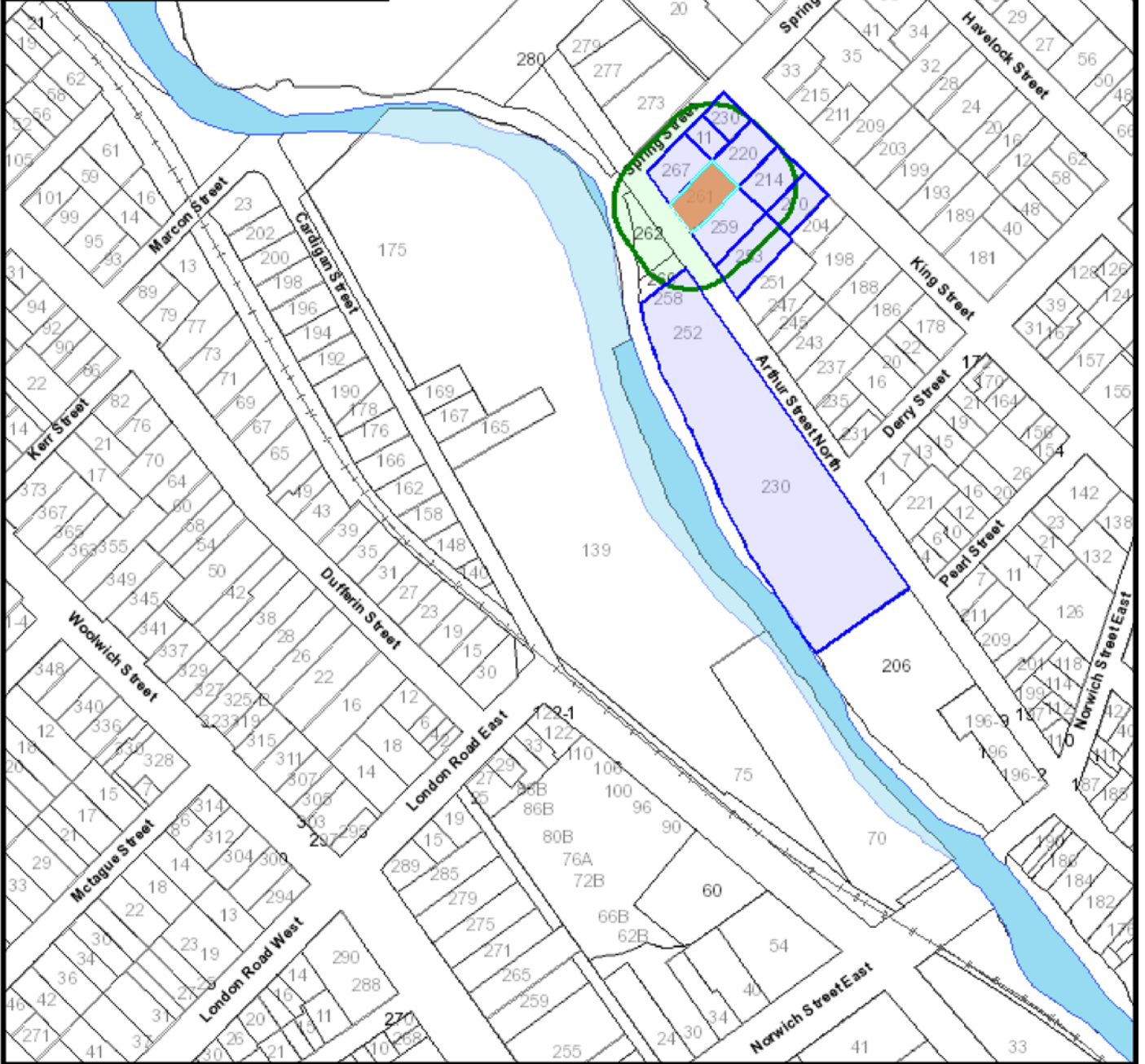
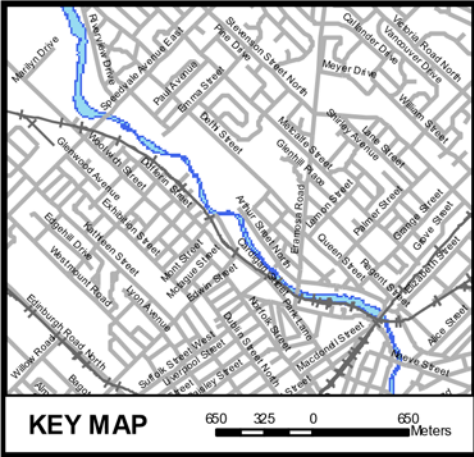
