**An application for consent [new lot] has been filed with the Committee of Adjustment**

## Application Details

### Location:

516 Imperial Road North

### Proposal:

The applicant is proposing to sever part of the subject property to create one new industrial lot and one retained industrial lot. The applicant is proposing to retain the existing industrial building on the proposed retained lands.

### By-Law Requirements:

The property is located in the Industrial (B.3) and Specialized Industrial (B.3-6) Zones, according to Zoning By-law (1995)-14864, as amended. The property is also located in the Industrial (B) Zone, according to Zoning By-law (2023)-20790, as amended.

### Request:

The applicant proposes to sever a parcel of land with frontage along Imperial Road North of 58.5 metres and an area of 7,065.3 square metres. The retained parcel is proposed to have frontage along Imperial Road North of 51.23 metres and an area of 6,252.1 square metres.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. If a person or public body that files an appeal of a decision of the Committee of Adjustment in respect to the proposed consent does not make written submissions to the City of Guelph Committee of Adjustment before it gives or refuses to give provisional consent, the Ontario Land Tribunal may dismiss the appeal.

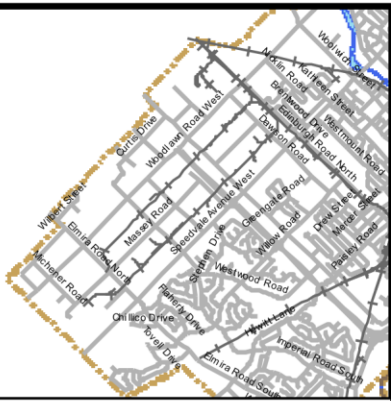
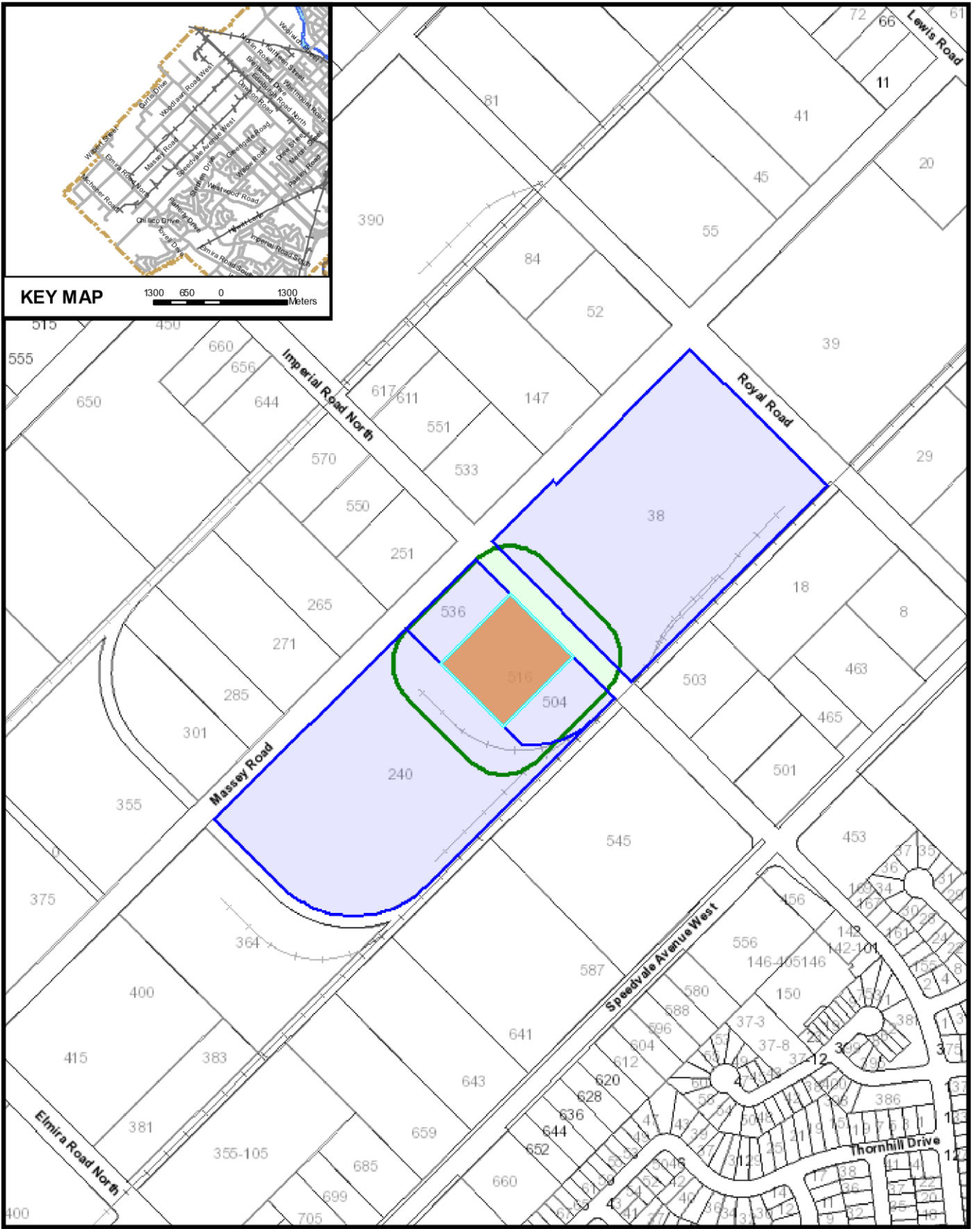
