

Committee of Adjustment Notice of Public Hearing



An Application for Minor Variance has been filed with the Committee of Adjustment

Application Details

Location:

10 Eleanor Court

Proposal:

The applicant is proposing to construct a fence in the front yard of the subject property, along the lot line facing Eric Court.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. A variance from Section 4.20.9 of Zoning By-law (1995)-14864, as amended, is being requested. The By-law requires that, within a residential zone, a fence located in the front yard shall not exceed 0.8 metres in height.

The property is also located in the Low Density Residential 1 (RL.1) Zone. A variance from Section 4.16.3(a)(i) of Zoning By-law (2023)-20790, as amended, is being requested. The By-law requires that, on a residential property located on a corner lot, and where the principal entrance of a single-detached or semi-detached dwelling faces the exterior side lot line, a fence located in the front yard shall not exceed 1.9 metres in height from the midpoint of the main building to the interior side lot line when located up to 0 metres of a front lot line.

Request:

The applicant is seeking relief from the requirements of both By-laws to permit a proposed fence with a maximum height of 1.9 metres in the front yard, located from the front face of the main building (not the midpoint) to the front lot line of the property, and located outside of the sight line triangle for the subject property.

Hearing Details

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing.

Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. Notice of the Decision

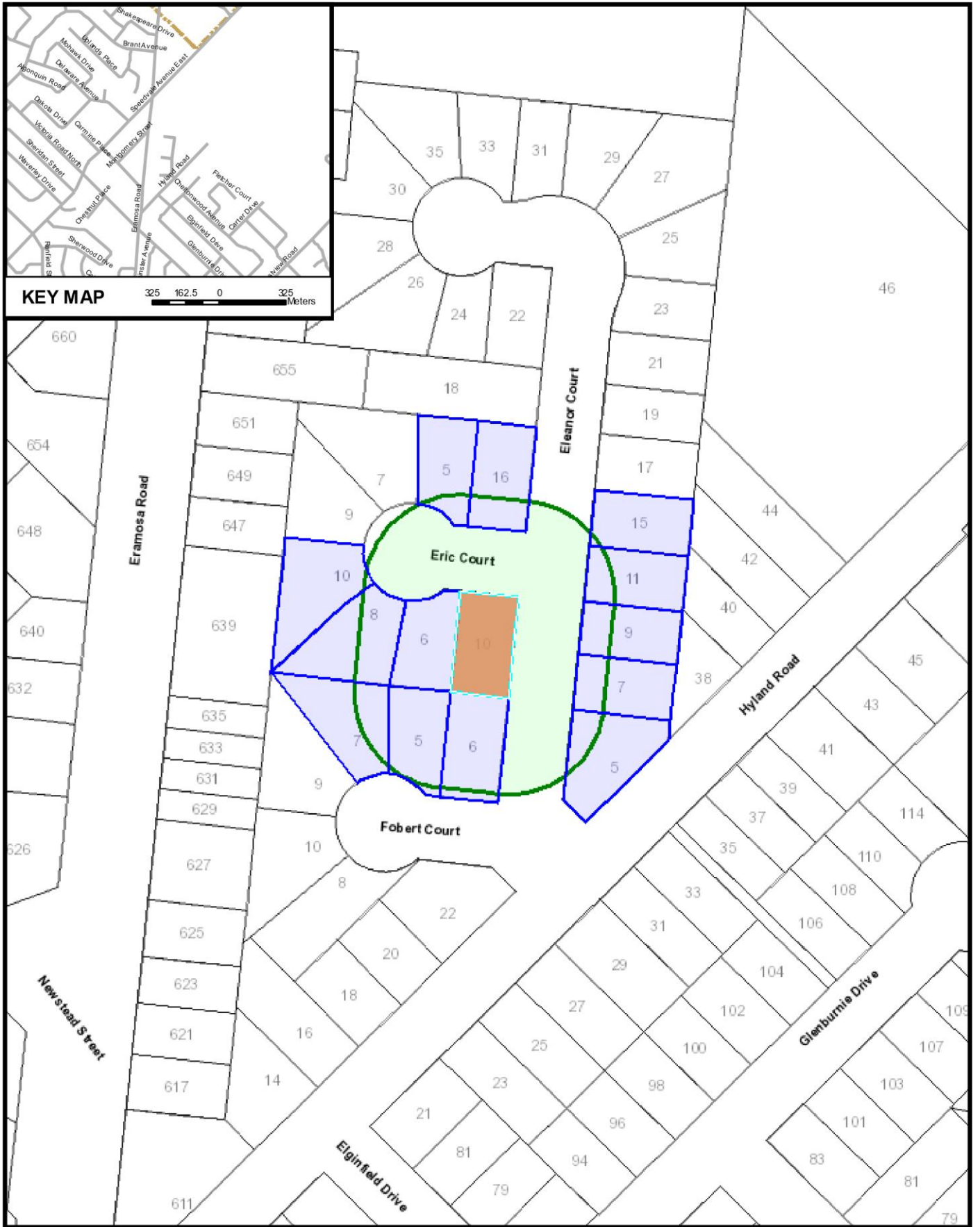
