

# Committee of Adjustment Notice of Public Hearing



**An application for consent [new lot] has been filed with the Committee of Adjustment**

## Application Details

### Location:

37 McCrae Boulevard

### Proposal:

The applicant is proposing to sever part of the subject property to create one new residential lot and one retained residential lot. The applicant is proposing to retain the existing dwelling on the proposed retained lands and to demolish the rear portion of the existing dwelling including the double car garage and shed. A new detached dwelling is to be constructed on the proposed severed lands. Due to the lot reconfiguration, a minor variance application is required for the proposed retained parcel (see file A-64/23, attached).

### By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone, according to Zoning By-law (1995)-14864, as amended. The property is also located in the Low Density Residential 1 (RL.1) Zone, according to Zoning By-law (2023)-20790, as amended.

### Request:

The applicant proposes to sever a parcel of land with frontage along James Street West of 17.7 metres, a depth of 26.1 metres, and an area of 461 square metres. The retained parcel is proposed to have frontage along James Street West of 20.4 metres, a depth of 26.1 metres and an area of 532 square metres.
