

# Committee of Adjustment Notice of Public Hearing



**An Application for Minor Variance has been filed with the Committee of Adjustment**

## Application Details

### Location:

425 Elizabeth Street

### Proposal:

The applicant is proposing to demolish portions of the existing industrial building and construct an addition to the existing building.

### By-Law Requirements:

The property is located in the Industrial (B.4) Zone. A variance from Table 7.3 Row 4 of Zoning By-law (1995)-14864, as amended, is being requested. The By-law requires that the minimum side yard setback be one-half the building height [3.89 metres] to a maximum of 9 metres, but not less than 3 metres, for a property located in the B.4 Zone.

The property is also located in the Industrial (B) Zone. A variance from Table 10.3 of Zoning By-law (2023)-20790, as amended, is being requested. The By-law requires a minimum interior side yard setback of 6.0 metres for a property located in the B Zone.

### Request:

The applicant is seeking relief from the requirements of both By-laws to permit a minimum right side yard setback of 3.0 metres for the proposed addition to the existing industrial building.

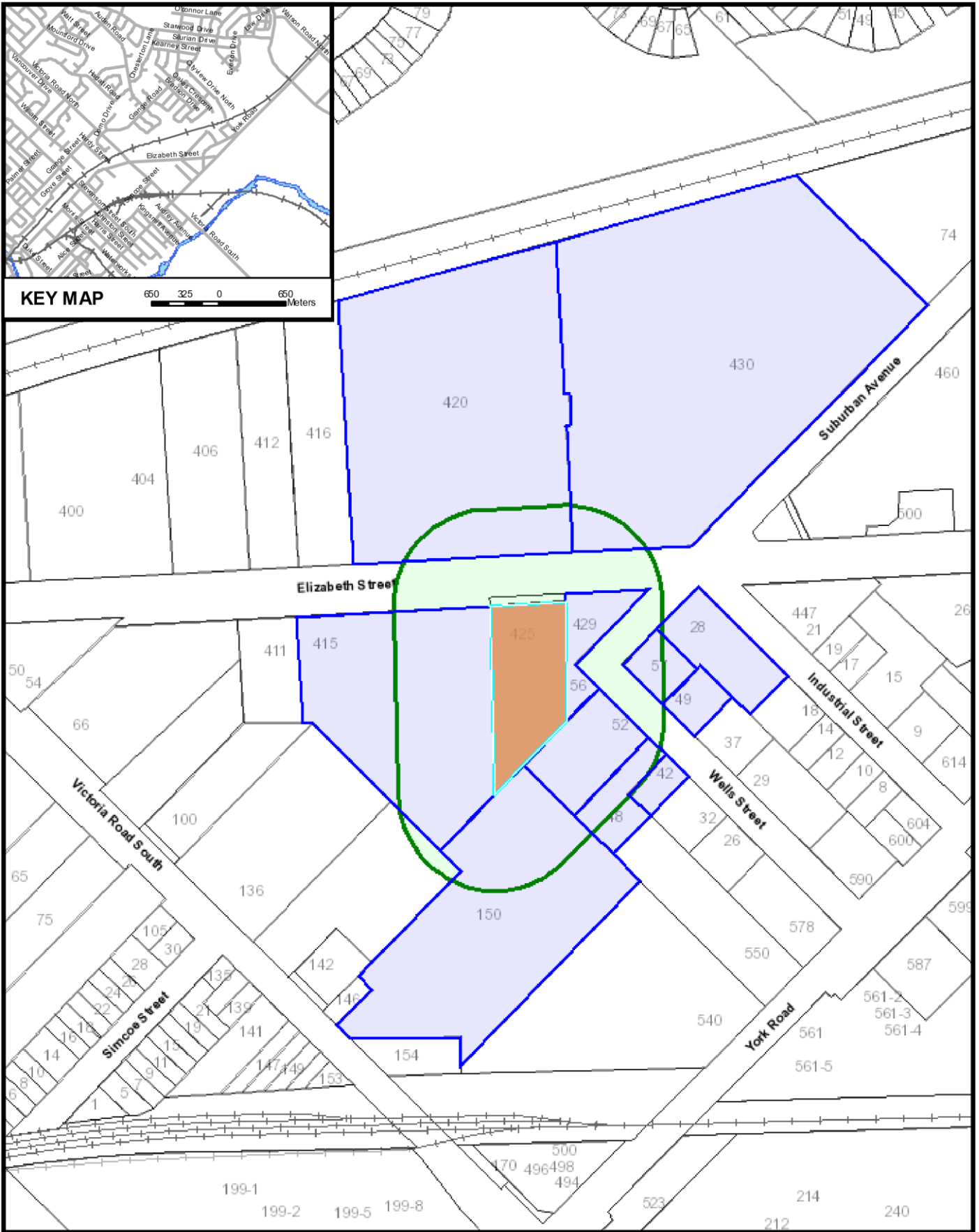
