

Committee of Adjustment Notice of Public Hearing



An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

55 and 75 Cityview Drive North (Block 130)

Proposal:

The applicant is proposing to construct 32 residential units comprised of two-storey townhouses and stacked townhouses on Block 130 of the Cityview Subdivision (Phase 2). The property is also subject to a minor variance application for Blocks 131 and 132 (file A-73/22, see attached).

This property is currently subject to an application for site plan approval (file SP22-123) and a draft plan of subdivision (file 23T-12501).

By-Law Requirements:

The property is located in the Specialized Residential Townhomes (R.3A-57) Zone.

The property is also located in the Site-specific Low Density Residential 4 (RL.4-7) Zone. Variances from Sections 5.2.2(c), 5.3.2(a) and Table 5.2 Row 3, 5.9(b), Table 6.19 and Table 5.10, Row 3 of Zoning By-law (2023)-20790, as amended, are being requested. The By-law requires:

- a) that on a lot 9,000 square metres and greater, a maximum of 75% of the residential parking spaces shall be permitted in surface parking areas;
- b) that minimum parking space dimensions for an apartment building (over 3 units), mixed-use building, stacked townhouse, stacked back-to-back townhouse and non-residential uses (interior or exterior parking spaces) be 2.75 metres in width and 5.5 metres in length;
- c) that a minimum of 80% of total required parking spaces for multi-unit buildings with 3 or more dwelling units, townhouse-cluster, stacked, stacked back-to-back, and mixed-use buildings shall be provided as designed electric vehicle parking spaces;
- d) a minimum lot area per dwelling unit of 270 square metres for a townhouse unit in the RL.4 Zone;
- e) a minimum exterior side yard from a private street, back of curb, sidewalk or lot line of 4.5 metres for a townhouse unit in the RL.4 Zone;
- f) a minimum rear yard from a private street, back of curb, sidewalk or lot line be 7.5 metres for a townhouse unit in the RL.4 Zone;
- g) a maximum residential driveway width of 65% of the lot frontage [5 metres], or 5 metres, whichever is less, for a townhouse unit.

Request:

The applicant is seeking relief from the requirements of Zoning By-law (2023)-20790, as amended to permit:

- a) 100% of the residential parking spaces to be surface parking areas;
 - b) minimum parking space dimensions for the proposed townhouses to be 2.5 metres in width and 5.5 metres in length;
 - c) a minimum of 10% of the total required parking spaces on the subject property be provided as designed electric vehicle parking spaces;
 - d) a minimum lot area per townhouse unit of 225 square metres;
 - e) a minimum exterior side yard of 2.5 metres from a private street;
 - f) a minimum rear yard of 4 metres from a private street;
 - g) a maximum residential driveway width of 7 metres for two units located on the subject property (one in Building A and one located in Building B).

Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning proposals is considered a public record and will be disclosed to any individual upon request. 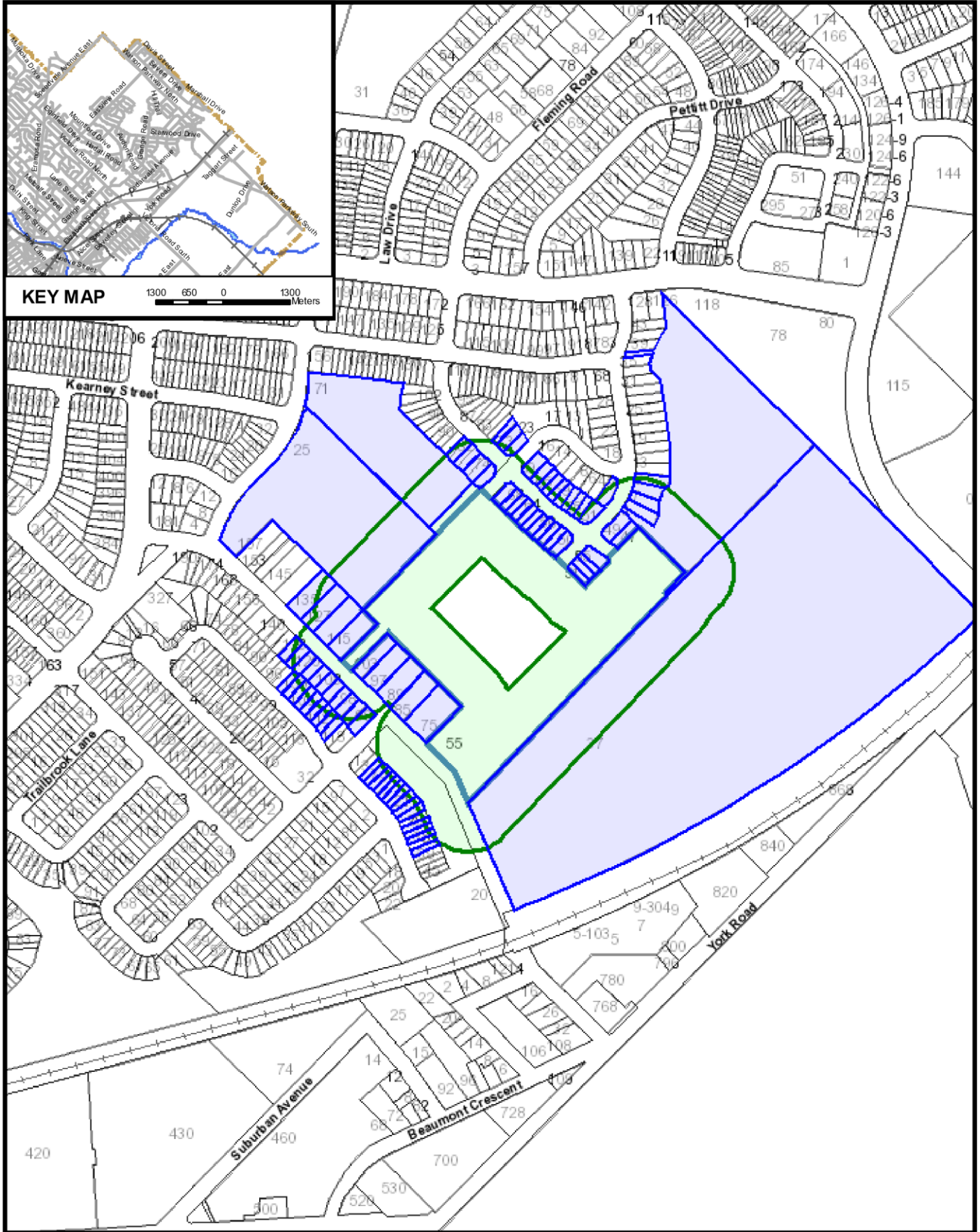
