

Committee of Adjustment Notice of Public Hearing



An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

127 Glasgow Street North

Proposal:

The applicant is proposing to extend the existing front porch and stairs, by constructing an uncovered extension to the existing open, roofed front porch.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone. Variances from Table 4.7 Row 2 of Zoning By-law (1995)-14864, as amended, are being requested. The By-law requires:

- a) a maximum projection into the front yard of 3 metres for an uncovered porch above 1.2 metres to a maximum height not exceeding the main floor/entry level; and
- b) a minimum setback from the front yard lot line of 0.8 metres for an uncovered porch above 1.2 metres to a maximum height not exceeding the main floor/entry level.

The property is also located in the Low Density Residential 1 (RL.1) Zone. Variances from Table 4.7.6 of Zoning By-law (2023)-20790, as amended, are being requested. The By-law requires:

- a) a maximum projection into the front yard of 3 metres for an uncovered porch not more than 1.2 metres above finished grade; and
- b) a 0.8 metre setback from the front lot line for an uncovered porch not more than 1.2 metres above finished grade.

Request:

The applicant is seeking relief from the requirements of both Zoning By-laws to permit:

- a) a maximum projection into the front yard of 4 metres for the proposed front porch addition and exterior stairs; and
- b) a minimum setback from the front lot line of 0.3 metres for the proposed front porch addition and exterior stairs.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 45 of the Planning Act R.S.O. 1990 P.13, as amended.

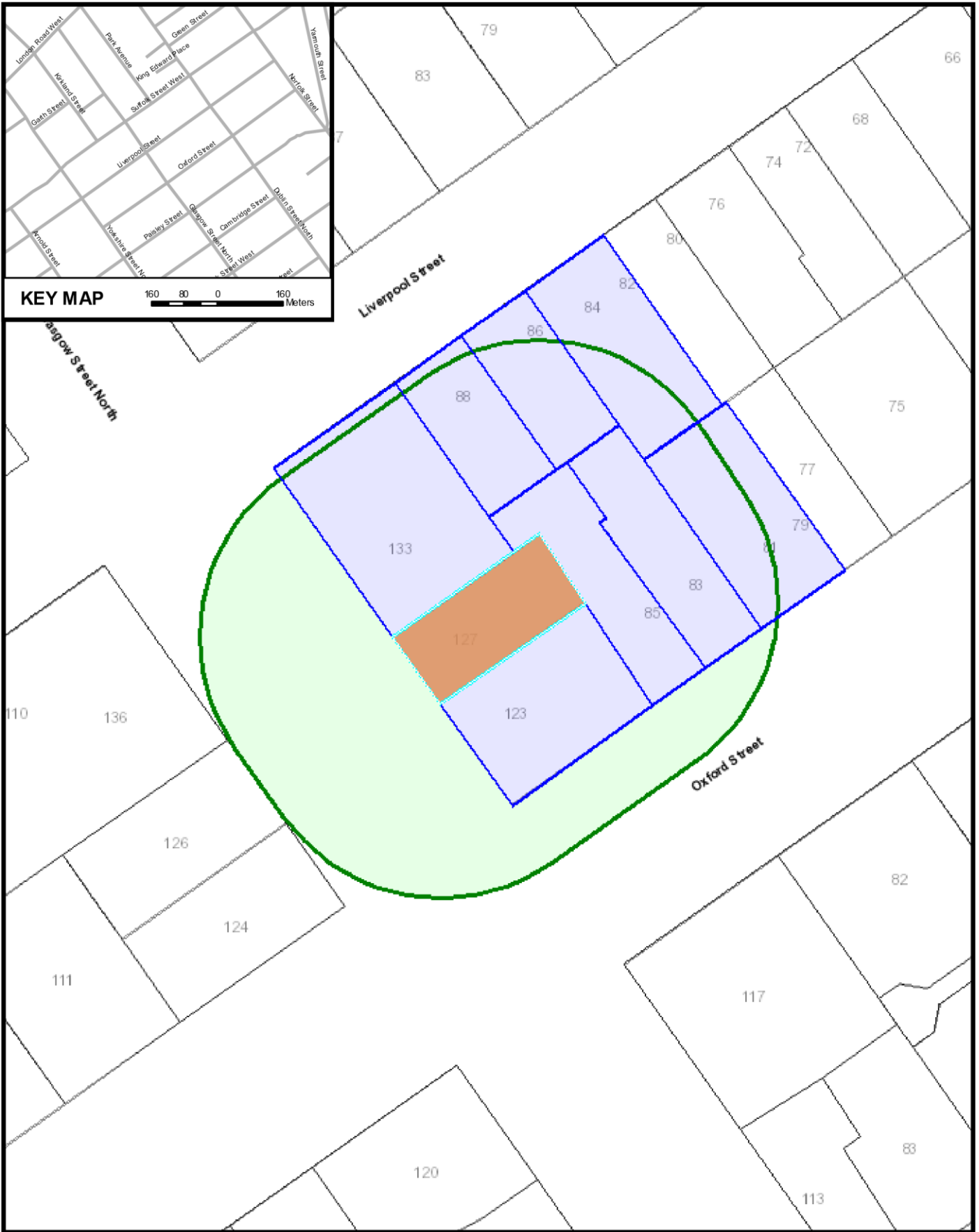
