An Application for Minor Variances has been filed with the Committee of Adjustment

Application Details

Location:

31 Margaret Street

Proposal:

The applicant is proposing to construct an addition to the existing single detached dwelling with a second floor balcony.

By-Law Requirements:

The property is located in the Specialized Residential Single Detached (R.1B-10) Zone. Variances from Table 5.2 Row 8 and Table 5.1.2 Row 7 of Zoning By-law (1995)-14864, as amended, are being requested. The By-law requires:

- a) a minimum rear yard of 7.5 metres or 20% of the lot depth, whichever is less; and
- b) a minimum side yard setback of 1.5 metres.

The property is also located in the Low Density Residential 2 (RL.2) Zone. Variances from Table 6.3 and Table 4.7.2 of Zoning By-law (2023)-20790, as amended, are being requested. The By-law requires:

- a) a minimum rear yard of 7.5 metres or 20% of the lot depth, whichever is less; and
- b) that a balcony (applicable to floors above main floor/entry level) has a minimum setback from a lot line of 2 metres.

Request:

The applicant is seeking relief from the requirements of both Zoning By-laws to permit:

- a) a minimum rear yard setback of 0.96 metres for the proposed addition to the existing single detached dwelling;
 - b) a minimum setback from the interior side lot line of 1.288 metres for the proposed second floor balcony.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. 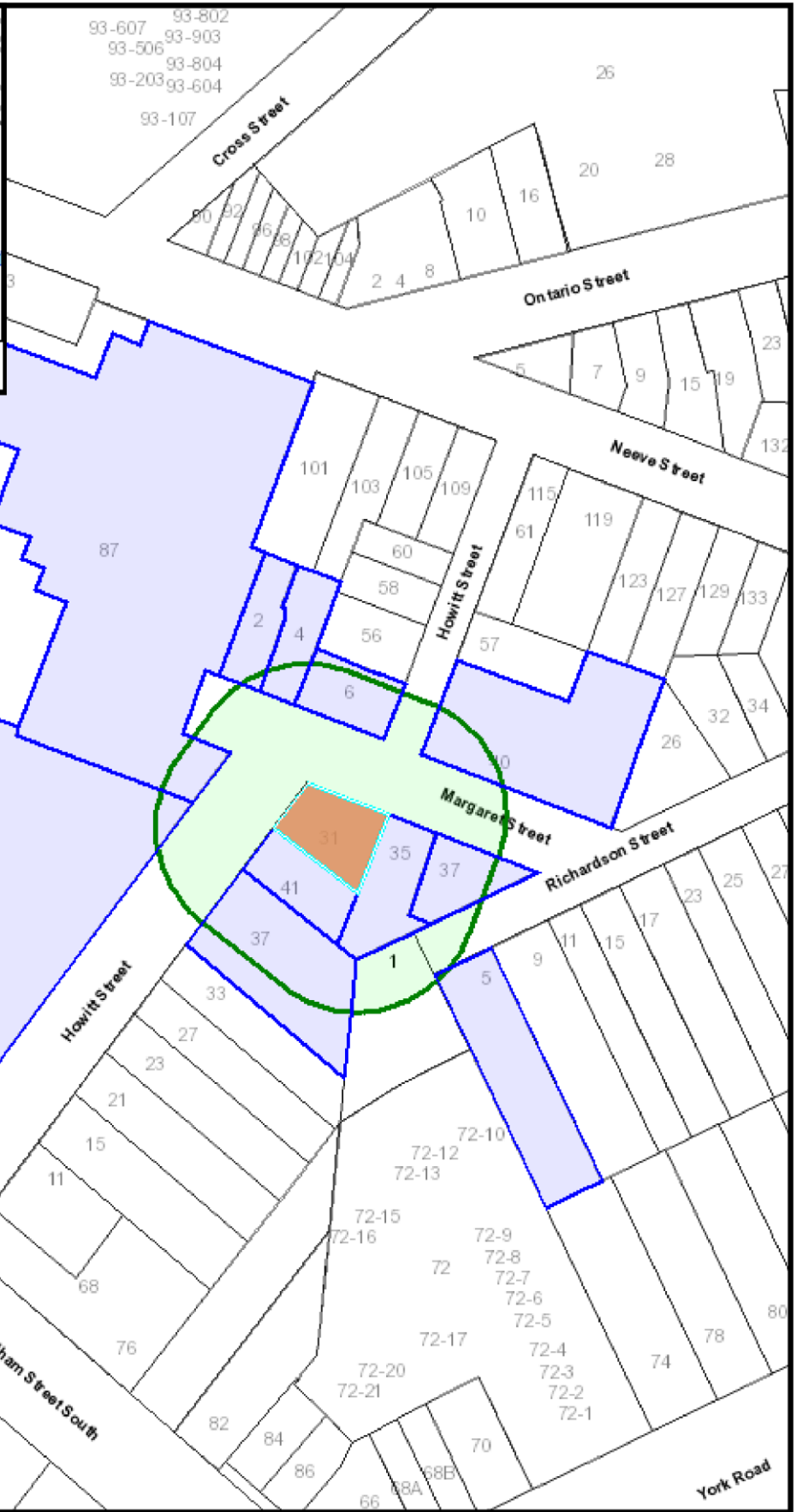
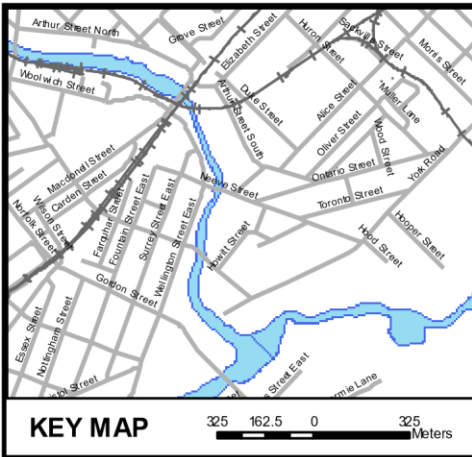
