An application for Consent [Easement] has been filed with the Committee of Adjustment

Application Details

Location:

59 Essex Street

Proposal:

The applicant is proposing to recognize the existing parking arrangement by creating an easement over a portion of 59 Essex Street, for use by the adjacent property at 61 Essex Street. The existing easement for parking is proposed to be extinguished and this new easement proposed in its place.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone, according to Zoning By-law (1995)-14864, as amended. The property is also located in the Low Density Residential 1 (RL.1) Zone, according to Zoning By-law (2023)-20790, as amended.

Request:

The applicant proposes to create an easement with a width of 3.1 metres and an area of 7.5 square metres over a portion of 59 Essex Street, for the purposes of access and parking, in favour of the adjacent property at 61 Essex Street.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 53 of the Planning Act R.S.O. 1990 P.13, as amended.

If you wish to speak to an application, please email or phone Committee of Adjustment staff no later than **12:00 p.m. the day before the hearing**. Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning

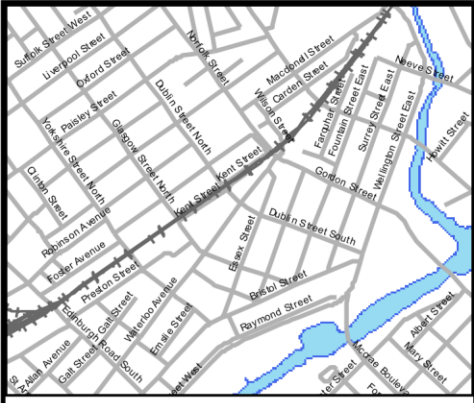

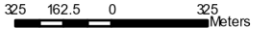
