Application Details

Location:

225 Paisley Street

Proposal:

The applicant is seeking approval in perpetuity for the existing temporary driveway easement over a portion of 225 Paisley Street in favour of 229 Paisley Street, shown as Part 1 on the attached plan.

By-Law Requirements:

The property is located in the Residential Single Detached (R.1B) Zone, according to Zoning By-law (1995)-14864, as amended. The property is also located in the Low Density Residential 1 (RL.1) Zone, according to Zoning By-law (2023)-20790, as amended.

Request:

The applicant is requesting consent for a permanent easement with a width of 0.6 metres and an area of 17.1 square metres over a portion of 225 Paisley Street, for the purposes of access and parking, in favour of the adjacent property at 229 Paisley Street.

The Committee of Adjustment for the City of Guelph will be holding a public hearing to consider an application under Section 53 of the Planning Act R.S.O. 1990 P.13, as amended.

Please indicate your name, phone number and the application number or address of the property you wish to speak to. When we receive your request, we will send you confirmation and instructions for participating in the hybrid public hearing. Instructions will also be provided during the hearing to ensure those watching online or in-person will be given the opportunity to speak.

Your comments, including any personal information you provide, will become part of the decision making process of the application and will be posted on the internet. Pursuant to Section 27 of the Municipal Freedom of Information and Protection of Privacy Act, R.S.O. 1990, c.M56, as amended, public feedback to planning

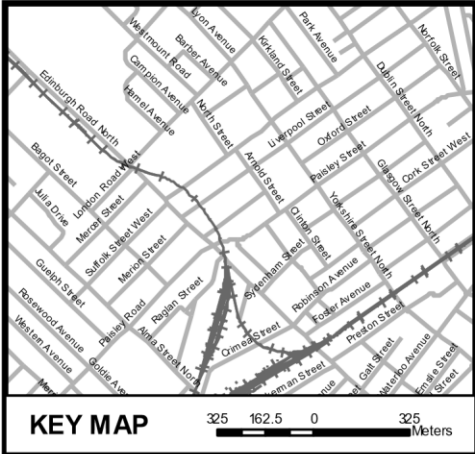
