**An Application for Minor Variances has been filed with the Committee of Adjustment**

## Application Details

### Location:

1-3 Quebec Street

### Proposal:

The applicant is proposing to construct a second floor balcony.

### By-Law Requirements:

The property is located in the Specialized Downtown 1 (D.1-1) Zone of Zoning By-law (1995)-14864, as amended.

The property is also located in the Site-Specific Downtown 1 (D.1-1) Zone. A variance from Table 4.7.2 of Zoning By-law (2023)-20790, as amended, is being requested. The By-law requires a minimum setback from a lot line of 2 metres for balconies above the main floor/entry level.

### Request:

The applicant is seeking relief from the requirements of Zoning By-law (2023)-20790 to permit a minimum setback from the interior side and rear lot lines of 0.15 metres for the proposed second floor balcony.

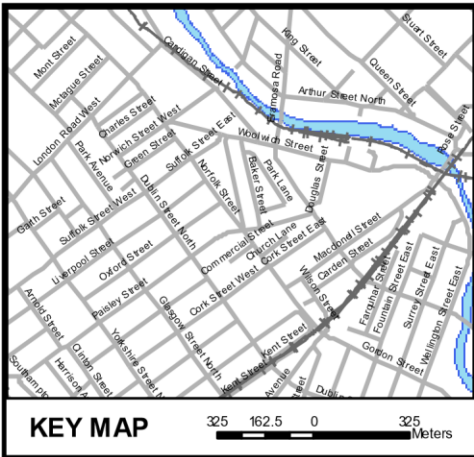
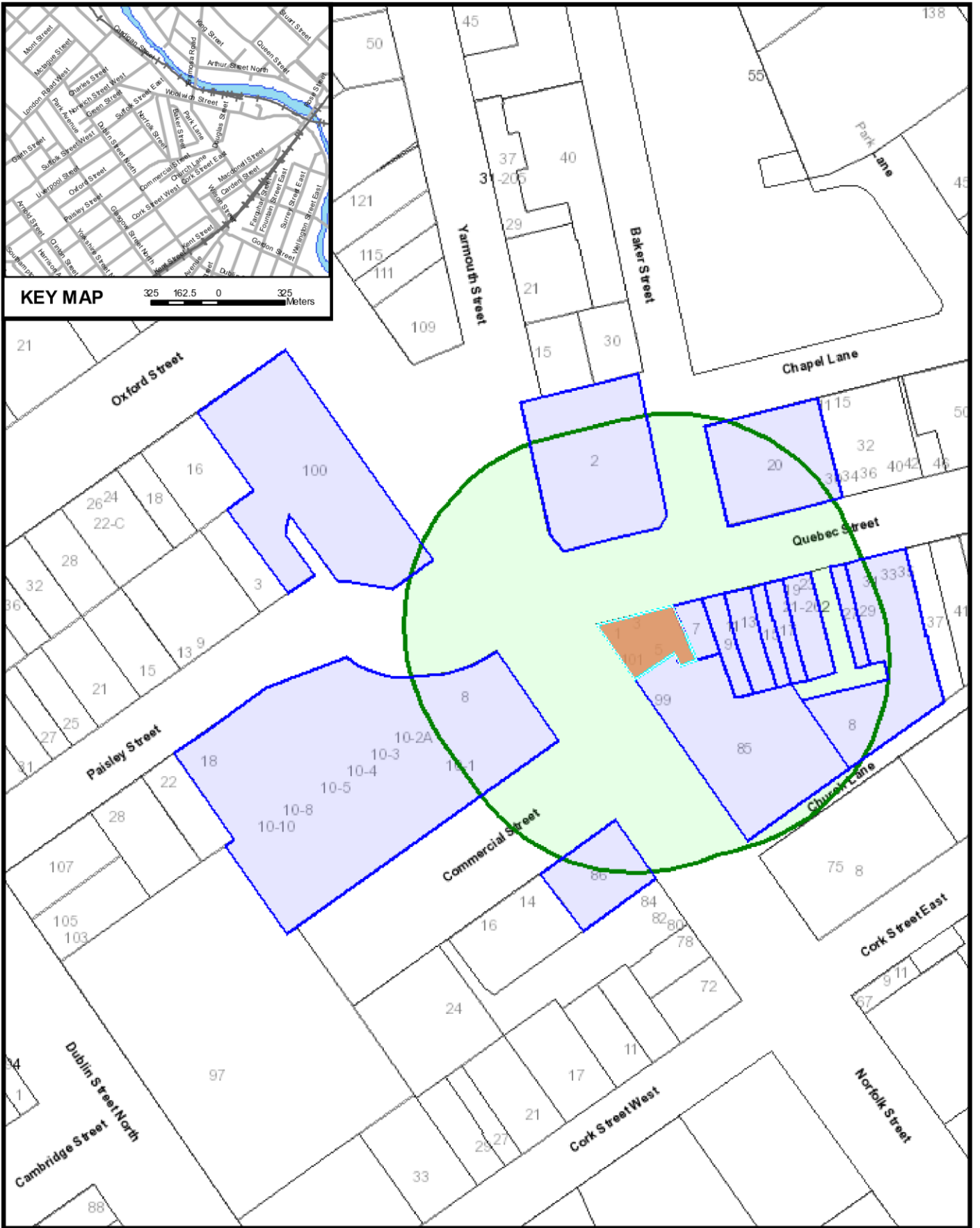
